1.	<p>Labour charges for providing earth terminal at the consumer premises. Scope of work:- (1) Each earth terminal shall be provided by digging a pit of 1800mm x 600mm x 600mm. The pit shall be atleast 1200mm far from the nearest support. The contractor shall lower the earthing coil/ C I plate provided by the company to the pit and make connection through to the external terminal of the metering point. The pit will be filled in by alternate layers of wood charcoal and salt cubes each of 30cms till the 1500MM from bottom. Remaining 300mm shall be refilled by earth dug out. The contractor shall have to provide Wood charcoal and the salt cubes on his own.
