1	<p>Labour charges for providing earth terminal at the consumer premises.</p> <p>Scope of work:- (1) Each earth terminal shall be provided by digging a pit of 1800mm x 600mm x 600mm. The pit shall be at least 1200mm far from the nearest support. The contractor shall lower the earthing coil/ C I plate provided by the company to the pit and make connection through to the external terminal of the metering point. The pit will be filled in by alternate layers of wood charcoal and salt cubes each of 30cms till the 1500MM from bottom. Remaining 300mm shall be refilled by earth dug out. The contractor shall have to provide Wood charcoal and the salt cubes on his own. (2) The remaining material like Earth lead GI wire to the earth terminal of the metering point, Rigid PVC pipe to cover the lead wire, C I earthing plate / coil, sundries material like G I Nut bolts etc., shall be provided by the company. The lowest tender whose tender is accepted shall have to pay 5% Security deposit of the Order value within 10 days from the receipt of the acceptance order. If you fail to supply the material within time limit your security deposit will be forfeited.

Any dispute of difference arising under this connection with contract shall be subject to the exclusive jurisdiction of UGVCL Deesa-2 Division.
- 5). **Payment:-**  
The payment will be made within 30 days on completion of work by crossed cheque on Local bank subject by and advance stamped receipt being received from payee.

- A. The tenderer must quote his rate per units specified the schedule including all taxes in Figures as well as in words. It there is difference between rates quoted in words or figures Quoted in words shall prevail.
