Terms and Conditions for supply of 11KV 400 Amps. Gang operated change over switch

- 1. The rates quoted in tender should be inclusive of all taxes, sale tax other Govt. Taxes, etc. in this regards, also sale tax registration no. Should be given. The rate should be quoted in numerical and worded figures as taking into account units shown in Schedule"B". In case of any dispute or discrepancy between rate quoted in numerical and worded figures, the rate quoted in words shall prevail. The rates accepted are for supply at **Regional Store Office**, **Palanpur** nothing will be paid extra. The unloading would be on Company's account.
- 2. Earnest money should be paid in cash and receipt thereof should be attached with the tender. In case renderer will be failed to execute the contract or fulfill the necessary formalities, the EMD will be forfeited.
- 3. The successful tenderer whose tender is accepted unquestionably shall have to pay security deposit @ 10% of order value within 10 days from the date of receipt of order; the same is liable to forfeiture by the Company in the event of non execution of order and non-observance of fulfillment of terms and condition of this contract.
- 4. Payment will be made after receipt of materials in good condition certified by Recording Officer with adequate satisfaction. All payment against this order will be made through A/c. Payee Chaque of any scheduled bank in favour of UGVCL, Palanpur subject to Advance stamped receipt received from you.
- 5. The entire materials should be supplied within a period of 30 days from the date of orders. Time factor is very essential; it will be ascertained before we place orders for supply of goods. In case the materials will not be delivered within the period stipulated in the order, you will liable to pay at the discretion of the competent authority, a penalty to the Company up to ½% per week on the price subject to a maximum of 10% reckoned on the order value of such materials. Due consideration will be given in the levy of penalty for reason absolutely beyond your control for which documentary evidence will have to be produced to the satisfaction of the competent authority of the Company.
- 6. In case the assigned store materials are not found in accordance with prescribed specification and approved sample, the Company shall exercise its discretionary power either to recover from supplier or by way of penalty or to purchase from elsewhere at the risk and cost of supplier. The defective and having bad designs and imperfect other than specified in Schedule-"B" will not be accepted and it will be rejected at the cost and risk of supplier.
- 7. The lowest tenderer whose tender is accepted shall have to produce experience certificate for supply of such materials satisfactorily.
- 8. General terms and conditions of Company's will be also applicable.



- Sale-tax No. may please be quoted otherwise sale-tax leviable as per prevailing 9. rate will be recovered from bill presented in this regard.
- 10. The tenderer while submitting the tender must sign all the correction whatsoever made in the tendered rate. Any tender received late in this office for any reason will not be considered.
- 11. The tender's own conditions for considering contract order will not be considered as forming the part of the tender. The tender must be signed unfailingly in the tender wherever it is found relevant and necessary.
- 12. All the quotation dispute or differences arising under out of or in connection with the contract if concluded shall be subject to the exclusive jurisdiction of the court with whose, jurisdiction the place from which acceptance of tender is issued is situated i.e. Palanpur.
- 13. The quoted rate of tender should be stood valid for the period of **90 days** from the date of opening.
