1	<p>Labour charge for providing earth terminal at the consumer premises. Scope of work:- (1) Each earth terminal shall be provided by digging a pit of 1800mm x 600mm x 600mm. The pit shall be at least 1200mm far from the nearest support. The contractor shall lower the earthing coil/ C I plate provided by the company to the pit and make connection through to the external terminal of the metering point. The pit will be filled in by alternate layers of wood charcoal and salt cubes each of 30cms till the 1500MM from bottom. Remaining 300mm shall be refilled by earth dug out. The contractor shall have to provide Wood charcoal and the salt cubes on his own. (2) The remaining material like Earth lead GI wire to the earth terminal of the metering point with ½” PVC pipe to cover lead wire, C I earthing plate/ Coil, Sundry material like G I Nut bolts etc. Shall be providing by the company. Sealed Tenders are invited for the work of Open Tender for Providing effective Coil type of earthing to Domestic consumer premises by labor charge at **Deodar-I S/Dn** under Radhanpur D.O. from the contractors/firms who have executed works of similar nature and magnitude successfully and who are registered under appropriate class.

Tender documents are in two bids system i.e. "Technical Bid" and "Price Bid".

- A. Technical bid is to be submitted in a separate sealed envelope and super scribing the envelope as "Technical Bid". Technical bid should be submitted with documents as under, failing which tender is liable for rejection.
 - B. Solvency certificate issued from any Nationalized Bank amounting to sum equivalent of estimated cost (Minimum 10.0 Lacs)
 - C. Separate EPF code No. allotted by RPFC & Last Six month of current year EPF Challan paid copy is required.
 - D. Latest income tax clearance certificate.
 - E. **Service tax registration number.**
 - F. **Vendor registration from Corporate Office as per Class-B & above.**
 - G. Group Insurance copy of the insurance policy of the insured laborer's under W.C. Act.
 - H. Experience certificate as per requirement for providing effective Coil type of earthing to Domestic consumer premises by authorized officer of Distribution Company more than three years experience.
 - I. Details of equipments available with the tendered.
 - J. Electrical contractor license as a when required.
 - K. Tools & tackle Certificate.
 - L. At least Rs. 10 Lacs turn over required in bank Statement.
 - M. Proof regarding payment of Tender Fee and EMD. The above supplementary documents should be submitted in form of attested true copies.

- 8 Intending bidders should submit their tenders after studying all tenders documents carefully and visiting the site for satisfying themselves of actual site conditions, location and accessibility of site and nature, extent of the work involved etc. Submission of tenders implies that bidders have obtained all necessary.
 - 9 Information and other data required for executing the work. No claim for extra charges on account Of any misunderstanding or otherwise will be allowed.
 - 10 All approaches to the site shall be in the scope of bidders.
 - 11 Bidders will not be allowed to give sub-contract of the works awarded to him for any, reasons what so ever without permission of the Engineer-in charge.
 - 12 In the experience certificate, contractor has to furnish the details of similar works executed by him along with the list of equipment, tools and tackles and manpower available with him along with the details of the same, which he intends to deploy on site of the work.
 - 13 After opening of “Technical bid” no revised price bid from any bidders will be accepted.
 - 14 Price quoted shall be firm, till overall completion of the work, under contract and there will not be any price escalation.
 - 15 Date of opening of “Price Bid” will be intimated later on to those Bidders who are qualified in technical bid. “Price bid” of only qualifying bidders on the basis of Technical bid shall only be opened. Price of bidders, who are not qualified technically as per requirement of technical bid shall not be opened.
 - 16 Offers shall be valid for the period of 120 days from the date of opening of price bid. Tenders shall not withdraw tenders during the validity period, failing which their EMD shall be forfeited during the said period of 120 days.
 - 17 Bolts & nuts of appropriate size and quality will be supplied by the **UGVCL Compaly.**
 - 18 Cement will be issued as per Company existing rates.
 - 19 Materials will be issued strictly as per requirement & not in lot
 - 20 Concrete slabs will be supplied from our store.
 - 21 “0.50 “ps. Per cu ft will be paid below the 2 feet or ground level for the rocky soil against the certificate of Dy. Engineer in charge/verification by concern D.E. tech of Radhanpur Division.
 - 22 Due care should be taken while doing the work, If any accident will occurred to your employee/personal while working than it will be your responsibility. Company will not be responsible for payment of any claims due to such accident.
 - 23 Contractor should observe labour laws as per prevailing rules of Govt. of Gujarat.
 - 24 Tree Branches should be trimmed such a way that distance of nearby conductor and trimmed branch must remain 5’ Horizontal and 5’ vertically.
 - 25 Pin binding of Pin Insulator must be with double strand of conductor.
 - 26 Each and every shackle pole must be re jumpered with formation of ‘D’.
 - 27 Old material removed from line (If any) must be credited in Divn. Store.
 - 28 All tools, tackles used in maintenance will be provided by contractor.
 - 29 Transportation of labour for the work should be done by contractor.
 - 30 If necessary order of one S/Dn. will be transferred to other S/Dn. depending upon requirement of UGVCL.
 - 31 The clearance as per I.E rules must be maintained.
 - 32 For any dispute jurisdiction of legal will be at **Radhanpur.**
 - 33 If the Tenderer/Bidder/Contractor would stand lowest while opening of the tender, He will be intimated by the competent authority with separate letter & will have to provide their skilled Labours gang within week time & He would have to report in written through respective SDO. Otherwise Second lowest bidder will be given chance at the rate of lowest-1.

- 34 The contractor should have to keep permanently skilled Labours gang in respective Sub-Division for each annual order. If Concern SDO will report that Erection Work is delayed due to non-availability of skilled labour , penalty will be deducted a per rules.
 - 35 All the works shall be carried out as per specifications attached with the tender and relevant Indian Standard issued by Bureau Indian Standards. All materials procured should be confirming to relevant Indian Standard issued by Bureau of Indian Standard.
 - 36 Tenders, who do not fulfill all or any of the conditions of the tender of incomplete in any respect, are liable to rejection.
