TENDER FEE: -



Tender Fee is COMPULSORY. No exemption from payment of tender fees and no price preference to the small, cottage & tiny industrial units registered under small scale industries of Gujarat state and holding subsequent registration with PO/NSIC/DGS&D registration certificates for the item under tender. Tender Fee will be accepted by D.D. in favour of Uttar Gujarat Vij Company Ltd., payable at Palanpur. Cheque is not accepted & Tenders submitted without tender fee will not be accepted.

EARNEST MONEY DEPOSIT:-

EMD at 1 % of the estimated cost is to be paid by D.D. in favour of Uttar Gujarat Vij Company Ltd. payable at Palanpur Tenders without EMD are liable for rejection. The exemption in payment of EMD shall be given to the small, cottage & Tiny Industrial Units registered under small scale industries of Gujarat State and holding subsequent registration with CSPO/NSIC/DGS&D registration Certificates for the item under tender. GENERAL CONDITIONS:-

1. Validity of Tenders:-

All tenders shall be opened for acceptance by the company for a period of 90 days from the date of opening the tenders and may be further extend to 30 days, if required and the tenderer shall be bound to execute the supply on such acceptance

2. Acceptance of Tenders:-

The Company does not bind itself to accept the lowest or any tender either will any reason be assigned for the rejection; it is also not binding on the company to disclose



any analysis report on the tender.

3. Contract documents :-

The lowest tenderer whose tender is accepted will have to execute a stamped agreement in standard form of the company and will have to sign the booklet at his own cost. In case of partnership firms necessary partnership document will have to be produced for verification on authority to sign the bills measurements enter and into contract as well correspondence with the company. Wherever required necessary power of attorney will have to be produced.

4. Jurisdiction :-

Any dispute of difference arising out of or in connection with the contract if concluded shall be subject to the exclusive jurisdiction of Palanpur-1 Division

5. Materials :-

Materials are to be supplied at Palanpur-1 division store office and as per instruction by Ex.Engineer

6. The payments will be made to the supplier by RTGS or NEFT. 10 % amount of total bill will be kept as a retention money.

7. Accepting authority reserves the right to rejection of any or all tenders without assigning any reason thereof.

8 . Any tender which does not complete with the above requirement is liable to be rejected.

9. Additions and alterations of any kind in tender forms conditions etc. by the tenderer without the consent of the undersigned is not permissible

12. Addressing Tenders :-

13. 14. Deviation of specification:-

Preference will be given to tendering firms whose rates according to tender specifications.

15. Terms of payments:-

Bill shall be submitted by the supplier after completion of entire ordered supply.

16. Recording of measurements in the presence of supplier :-

(a) In case of supply carried out satisfactorily by the supplier, the supplier by prior intimation from the company's officers shall have to witness the recording of measurements on the appointment date within one month of completion of supply either the conditions as specification vide condition No. 5 read with condition



No.4(b) or tender and supply for works.

(b) Booklet shall apply and the recording of measurements shall be done within one month of completions of supply after replacement of defect by the company at the contractor's cost as the case may be and any further delay in the recording of measurement and finalization of the bill due to the fault of the supplier shall be subject to the conditions as laid down in clause (a)

17. Extension of time limit :-

The time limit for supplying materials is within 30 days from the date of issuing the orders. Extension of time limit if for any reasons, the suppliers is not in a position to supply within the stipulated period, he should put his application to the Engineer In charge before one month of expiry of the stipulated time limit or completion of supply for the extension of time limit giving valid reasons for the required extension.

Taxes and Duties:

The price ara excluding GST and CESS as applicable which will be paid extra on a given taxable goods and/or service within the original contractual delivery period. The amount and % of GST and CESS as applicable should clearly be indicated saperately. (GST/CESS means all applicable TAX/CESS under GST Laws. GST Laws means IGST Act, GST (Compensation to the Stae for Loss of Revenue) Act, CGST Act, UGST Act and SGST Act -2017 and all related ancilliary legislation).

Supplies/Contractor should charge GST in invoice at the rate as agreed to /mentioned in acceptance of Tender only and any deviation in the same shall not be accepted . Further any additional liability of GST (later on due to wrongmentioning of GST rate, mis interpretation of HSN/SAC code, etc.) over and above as charged in the invoice shall be borne by the Supplier/ Contractor. However , any refund received by the supplier / contractor on account og GST charged from the company , such refund shall have to be passed on to the company , along with interest if any. Such refund along with interest needs to be passed on suo-moto by the supplier/ Contractor.

Further the company has a right to recover the amount of GST along with penal interest at the rate of 15% per annum if GST charged is not paid /short paid to the government or fail to upload the details or uploads inaccurate particulars on GSTIN portal by the Supplier/ Contractor within the stipulated time limit.

In case , Govt. revises the rate of GST rate / Code during the tenure of the contract , the provision of UGVCL's statutory variation clause shall apply.

7) **TERMS OF PAYMENT :**



- (A) Payment for the work done will be made through running A/c bills to the extent of 100 % of the value of work done computed at the unit rates accepted in the tender provided the material account of respect of previous R.A. Bill is furnished before the next running accounts bill is paid.
- (B) If this is not complied will the payment through R.A., Bill to the extent of 80 % of the value of the work done will be made and the balance so with held will be released when materials account of previous R.A., Bill is furnished.
- (C) The payment will be made by A/c payee crossed cheque subject to on advance stamped receipt being received from you will in advance. payment made in 30 days after receipt of bill by Dvn.Office NO 1.Palanpur
- (D) The contractor will co-operate with company in recording measurements and he shall fulfill all the – requirements which are necessary to finalize his out standing bills within six months from the date of completion of work failing which the company shall finalize 6the account on the basis of its records and pay such amount as is found due to the contractor after taking in to account the amount of security Deposit if any remaining payable by ghim and after deducting the Amount due to the company.
The Board shall not entertain any further claim from the contractor thereafter.

(E) Income Tax as per Govt. rules in force will be deducted form R.A. / final respectively.

8) **PROGRESS OF WORK AND PENALTY :**

The work shall be carried out as per our specification given with the tender and shall be of high quality and as per P.W.D. Hand Book. If it is found that the work is unsatisfactory and not progressing as per the programme chalked out by the undersigned or Dy.E.Concerned, action would be taken as deemed fit to see that the work is completed as required by company at your risk & costs.

If the work is not completed within the time limit provided in clause No.4 above penalty at the rate 1% of the value of

the contract per day subject to a maximum of 10 % of the value of the contract will be levied unless extension in time

limit is granted for valid reasons by the competent authority.

PENALTY FOR LATE DELIVERY:

Penalty shall be @ 0.5% per Week or part thereof plus GST as applicable on delayed portion subject to maximum 10% plus GST as applicable of the delayed portion Order Value (End Cost with GST and Cess as applicable) in case of supply only, whereas in case of Project, the ceiling shall be with reference to total contract value with GST and Cess as applicable of the project (Supply +Erection+Civil) . For calculating the delayed portion, date of actual receipt of material at store shall be considered.

9) **STTUTORY REGULATIONS. :**



The Company will not take responsibility as regards workmen's compensation act or for other statutory Act. Rules or regulations that have to be observed by the Contractor for carrying out the Erection of ECO SAFE ELECTRILYATE EARTHING. Similarly the company will not take any responsibility for the work whether fully executed or not and all materials, plants tools building and other the things connect herewith which shall be at the risk and sole charge of the Contractor until the complete work is delivered to the Board and a completion certificate is obtained from the competent authority.

The Contractor shall at their own risk and cost take precautions reasonably necessary to keep all the aforesaid materials, machinery, plants tools and building and other allied things connected with the work from any loss or damage and in the event of the same or any part thereof of being lost or damage they shall forth with it and with all possible speed reinstate and make good the loss or damage at their own cost.

STATUTORY VARIATION:

Any statutory increase or decrease in the taxes and duties including GST and Cess as applicable or in the event of introduction of new tax/cess or cessation of existing tax/cess subsequent to contractors offer if it takes place within the original contractual delivery date will be to COMPANY's account subject to the claim being supported by documentary evidence. However, if any decrease takes place after the contractual delivery date, the advantage will have to be passed on to COMPANY.

18. GST

(A) The GST at the prevailing rate should be paid as per the rules.

Contractor shall have to pay whatever applicable taxes prevailing at the time of placement of order execution of work /Bill payment etc. "Since the tender in respect of this LOA/AT was floated under Pre GST Regime, this OA/A/T is issued considering Pre GST (Old Tax Structure), the supplier has to provide the details of ITC claimed/available under GST for supply of items under this OA/A/T duly certified by a practicing chartered accountant. The content, manner and formal of submission of ITC details will be intimated to the supplier in due course of time, the 20% payment of supply along with GST after adjusting the quantum of ITC shall be made against SR Note and on receipt of details of ITC in the prescribed formal duly certified by a practicing Chartered Accountant"

- 1) Sealed Tenders are invited for the work Providing and fixing of maintenance free electrode earthing as per specification under sub division of Palanpur-1 Division for diff. scheme. From the contractors/firms who have executed works of similar nature and magnitude successfully and who are registered under appropriate class.
- 2) Tender documents are in two bids system i.e. "Technical Bid" and "Price Bid".
 - 2.1 Technical bid is to be submitted in a separate sealed envelope and super scribing the envelope as "Technical Bid". Technical bid should be submitted with documents as under, failing which tender is liable for rejection.
 - 2.2 The sealed price bids comprising of Schedule-'B' should be submitted in separate sealed envelope super scribed accordingly on the envelope.
 - 2.3 Both "Technical" and "Price" bid should be submitted in one common envelope super scribing the name of the work and tender opening date etc.
- 3) Bidders should complete the tender documents in all respects and they are to be signed with Company's Seal on all pages.
- 4) The bidders shall submit their offer without any deviations in general terms and conditions of the contract or in Technical specification/items. Tenders of such departing may also be rejected. Incomplete and conditional tenders shall not be considered.

- 22) The contractor should have to keep permanently skilled labors gang in respective Sub-Division for each annual order. If Concern SDO will report that said Work is delayed due to non-availability of skilled labor, penalty will be deducted a per rules.
- 23) All the works shall be carried out as per specifications attached with the tender and relevant Indian Standard issued by Bureau Indian Standards. All materials procured should be confirming to relevant Indian Standard issued by Bureau of Indian Standard.

Specification for Eco friendly Maintenance Free Earthing

Maintenance free earthing system comprising of 50 X6 mm dia 3 mtr long Earth electrode of low Carbon steel electrode with 250 microns copper coating with a bag of (23 kg) of Carbon based environment friendly special backfill compound with a suitable GI clamp. Electrode

- The electrode shall be a solid steel rod made of high tensile low carbon steel and coated with molecularly bonded copper on the outside as per UL 467.
- The thickness of the copper coating shall be atleast 250 microns.
- The electrode diameter shall be 50 x6 mm.
- The earth electrode shall carry UL marking and manufacturer's name.
- The length of the electrode shall be 3 mtrs.

Chemical Compound (Backfill material)

Highly conductive and Eco friendly backfill material: The backfill material shall be highly conductive. The backfill Material shall be carbon based and of low resistance, non corrosive, highly conductive carbon based powdered material that improves grounding effectiveness, especially in areas of high soil resistivity such as rocky and sandy areas. This material shall be suitable to be installed in either slurry or dry form. The material shall attain the hardening characteristics of cement when mixed with water or exposed to moisture while retaining its' properties. The backfill material shall confirm to the

following specifications:

- a. Shall be highly electrically conductive and non-soluble.
- b. Shall not leak into ground.
- c. Shall have a resistivity of less than 0.1 ohm meter as per clause 14.5 (d) of IEEE 80
- d. Shall be compatible with all copper grounding systems
- e. Shall contain a corrosion inhibitor to mitigate corrosion of copper
- f. Shall not contain hazardous chemicals
- g. Shall not be affected by drought and shall be stable between -10° to + 50° C temperature.
- h. Shall not depend on presence of moisture for conductivity but shall be electronically conductive like metals.

- j. The compound should have been tested in a reputed laboratory for not containing any hazardous chemicals as per EPA Chapter 7.
- k. The compound shall be carbon based conductive concrete and shall not contain bentonite in any form.

The bottom 300mm of the bore hole shall be filled with good, preferably black cotton soil. The balance length of the bore hole shall be filled entirely with the backfill compound in pure form without mixing with soil. The compound shall bond tightly with the electrode and become a solid mass.
