- 2. No. Extra charge will be paid by company
- 3. Poor quality material is rejected.
- 4. GST Registration & Date must be required.
- 5. F.O.R. Deesa Store
- 6. Sample may be sent (if possible by courier) along with tender or before submission date of tender at Deesa Division-1 Store, otherwise your tender will be ignored No sample will be accepted after last date of receipt of tender.

1).A. Earnest Money Deposit:

Earnest Money Deposit 1% of the estimated cost or minimum Rs. 500 or indicated on the Tender copy should be paid by the tenderer along with the tender fee in cash or by Demand Draft on any Schedule bank in favor of UGVCL in which cash receipt shall be attached with Tender invariably.

Any dispute of difference arising under this connection with contract shall be subject to the exclusive jurisdiction of UGVCL Deesa-1 Division.

5). Payment:-

The payment will be made within 30 days on completion of work by crossed cheque on Local bank subject by and advance stamped receipt being received from payee.

6). <u>General:-</u>

All tender must be submitted in forms provided by this office and must be clearly & legibly Filled in. The tenders should be filled in ink. The tenderer are requested to sign wherever mentioned in tender and schedule or rates and if not signed the tender shall be rejected.

B). GOODS & SERVICE TAX(GST):-UGVCL GST Registration No. is:- 24AAACU6551F1ZI

The firm prices are exclusive of Goods & service Tax as applicable. The amount and rate (%) of GST as applicable should clearly be indicated separately. (GST means all applicable Tax/cess under GST laws. GST Laws means IGST Act, GST (Compensation to the State for Loss of Revenue) Act CGST Act, UTGST Act and SGSCT Act-2017 and all related ancillary legislations).Contractor should charge GST in invoice at the rate as agreed to/mentioned in acceptance of tender only any deviation in the same shall not be accepted. Further, any additional liability of GST (later on due to wrong mentioning of GST rate, mis-interpretation of HSN/SAC Code etc;) over and above as charged in the invoice shall be borne by the contractors.
