1	9902040002	Labour charges for providing earth terminal at the consumer premises. Scope of work:- (1) Each earth terminal shall be provided by digging a pit of 1800mm x 600mm x 600mm. The pit shall be at least 1200mm far from the nearest support. The contractor shall lower the earthing coil/ C I plate provided by the company to the pit and make connection through to the external terminal of the metering point. The pit will be filled in by alternate layers of wood charcoal and salt cubes each of 30cms till the 1500MM from bottom. Remaining 300mm shall be refilled by earth dug out. The contractor shall have to provide Wood charcoal and the salt cubes on his own. (2) The remaining material like Earth lead GI wire to the earth terminal of the metering point, Rigid PVC pipe to cover the lead wire, C I earthing plate / coil, sundries material like G I Nut bolts etc., shall be provided by the company. Tender fee +GST as applicable **A)**. The contractor should be registered under the Goods & Service Tax. The contractor not Having GSTIN shall not be considered for acceptance of the Tender.

B). PRICES:- The Bidder shall quote FIRM PRICES only. The prices quoted will not be subject to any escalation till completion work. The above prices are inclusive of all taxes, levies, Duties etc.except Goods & Service Tax (GST) will be paid extra as applicable from time to Time on a given taxable goods and/or services. Also please mention **SAC Code** and rate of GST as Applicable.

C). GOODS & SERVICE TAX(GST):- UGVCL GST No. is:- 24AAACU6551F1ZI

The firm prices are exclusive of Goods & service Tax as applicable. The amount and rate (%) of GST as applicable should clearly be indicated separately. (GST means all applicable Tax/cess under GST laws. GST Laws means IGST Act, GST (Compensation to the State for Loss of Revenue) Act CGST Act, UTGST Act and SGSCT Act-2017 and all related ancillary legislations).Contractor should charge GST in invoice at the rate as agreed to/mentioned in acceptance of tender only any deviation in the same shall not be accepted. Further, any additional liability of GST (later on due to wrong mentioning of GST rate, mis-interpretation of HSN/SAC Code etc;) over and above as charged in the invoice shall be borne by the contractors. Any delay that may take place in erection and commissioning activities beyond contractual out of date shall be subject to penalty at the rate of 2% of the contract value (of delayed materials/works) per month or part thereof subject to a maximum of 10% of total contract value, Plus GST as applicable.

CONDITIONS:

Bidder has to submit tender in one Envelop and in this two different covers should be put. One cover mentioning **Technical bid** on it & another cover mentioning **Commercial Bid** on it. If we receive envelop that do not have two separate sealed covers than those bids are liable to be rejected. Technical bid should be submitted with documents as under, failing which tender is liable for rejection.

(i) Solvency certificate issued from any Nationalized Bank amounting to sum equivalent of estimated cost. (Minimum 5 Lakh).

(ii) Separate EPF code No. allotted by RPFC & Last Six month of current year (Sep-2017 To Feb-2018) EPF Challan paid copy is required.

(iii) Latest income tax clearance certificate. With PAN card. (Assesment Year 2017-18)

(iv) Labour license certificate.

(v) Experience:-Contractor should produce evidence of executing similar nature & magnitude of work i.e.**Domestic consumer earthing** from any DISCOM of GUVNL. The Experience certificate of minimum **5 (five)** Years in which latest 3 years (i.e. 2015-2017) and satisfactory completion of work; issued by Executive Engineer of respective division is require.

(vi) Group Insurance A copy of the insurance policy of the insured laborer's under W.C. Act.

(vii) Details of equipments available with the tendered & Tools & tackle Certificate (viii) Valid Electrical contractor license.

(ix) At least Rs. 5 Lacks turn over required in current year. Current year (2017-18) bank statement required must.

(x) GST registration no must be submitted with tender.

(xi) Nationalised bank's Demand Draft of Tender Fee and EMD.

(xii) UGVCL VENDOR REGISTRATION IS REQUIRED.
