Dear Sir,

At the outset, we note from the letter that Hon'ble Commission has recognized the reasons for the short term open access curtailment and now sought our stand on the complaint from the consumer wherever open access is granted.

Point-1:

*"DISCOMs insistence on under drawal to be kept less than 12%"*

In this regard, we request you to refer to the reply of PGVCL vide letter dated 21.05.2014 and we agree in toto.

Further to above, we wish to add following:

Your contention that "regulation of Central Commission cannot be unilaterally applied by any licensee unless it has been explicitly adopted by the State Commission" requires to be clarified in line with GERC regulation No. 3 of 2010 and subsequent amendment of intra state ABT.

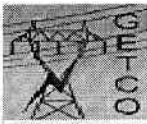
SLDC has to strictly adhere to CERC regulation of DSM w.e.f. 17.02.14 and grid is being operated accordingly. We have insisted on open access consumer to follow DSM mechanism after this date only. It is absolutely essential for all the stake holders to follow the mechanism; otherwise, SLDC would be issued notices for violating the mechanism. To support further, we wish to point out following regulation:-

Para 8 of Intra state ABT order 3 of 2010 provides for:

*"The basic UI rate for intra-state entities in Gujarat shall be in line with the CERC notifications on the matter as amended from time to time".*

And Para 10 provides for:

*"levy of additional UI charges at the rate stipulated in CERC from time to time".*

It is essential to keep these rates also applicable to the entities of Intra State ABT in line with above to avoid mismatch in energy accounting of Regional Pool as well as State Pool.

On one side, when the energy accounting is done as per operation rules of the DSM, how can we provide exemption to any consumer in the grid when the entire open access is carried out through exchange in ISTS network. We also wish to draw the attention of Hon'ble Commission to clause 4 of DSM regulation which reads as follows:

*"These regulations shall be applicable to sellers and buyers involved in the transactions facilitated through short-term open access or medium-term open access or long-term access in inter-State transmission of electricity".*

It would be inappropriate for DISCOM to face the under drawl / over drawl, violation of open access consumer without having their own deviation.

DISCOM has legitimately issued notices to consumers in light of above and therefore, there is no breach of regulations for the safe operation of the grid with the stipulated band of 12% of schedule or 150 MW whichever is less.

Point-2:

*"DISCOMs insisting on minimum 1 MW drawal at all times."*

In this regard, we request you to refer to the reply of PGVCL vide letter dated 21.04.2014 and we agree in toto.

Hon'ble GERC is recognising imbalance charges in regulation 32 of intra state open access regulation. If it is true, then SLDC should not be reprimanded for 12% deviation as under point No. 1.

Further, it is to state that RTC scheduling itself means adhering to drawl. Further, the Commission order No. 1226/2012 and 1325 of 2013 dated 18.10.2013 is not telling anything about drawl at all time. To put this matter of minimum 1 MW drawl to rest, we draw the attention of Commission to section 42 of Electricity Act 2003 which reads as follows:

Fifth proviso:

*"Provided also that the State Commission shall, not later than five years from the date of commencement of the Electricity (Amendment) Act 2003, by regulations, provided such open access to all consumers who require as supply of electricity where the maximum power to be made available at any time exceeds one megawatt".*

The Act is supreme and binding on all. Therefore, we will have to adhere to limit of exceeding of 1 MW. DISCOMs have legitimately issued notices to consumers in light of above and therefore, there is no breach of regulations for the safe operation of the grid.

Point-3:

*"Delay in issuing consent by the DISCOMs."*

Hon'ble Commission may please refer to the reply of DISCOM.

Point-4:

*"SLDC is refusing STOA on the pretext of non-receipt of consent from distribution licensees."*

As per the clause 12 (3) table 1 of Open access regulation 3 of 2011, short term open access consumer is required to obtain the consent from concerned DISCOM and apply to SLDC along with this, but the fact is that the consumers are applying directly to SLDC and then, SLDC is forwarding the applications to concerned DISOCM. As such, there is clear deficiency in the first instance and in fact, we are helping the consumers who are seeking the open access.

Under these circumstances, it may not be appropriate for consumers to blame SLDC and we have rejected open access applications only when we have clear denial from DISCOMs.

Further to clarify the word "non-receipt of consent from DISCOM", means denial from DISCOM in our communication in Format-3.

Point-5:

*"SLDC refusing STOA due to non-receipt of consent from the transmission licensee."*

In light of above, Hon'ble GERC may kindly note the effective role played by SLDC to facilitate STOA consumer for obtaining STOA.

While SLDC is an apex body to ensure integrated grid operation of power system in the State, it is essential that "Nodal agency shall check transaction for congestion of any element (line and transformer) of transmission and distribution system involved in transaction" as stipulated in the clause 15(2)(a)(ix) of Notification 3 of 2011.

It may not be appropriate for SLDC to grant open access, as nodal agency, without recognizing limitations / constraints of the grid and therefore, dependence and seeking advice from State Transmission Utility is inevitable looking into following grid operation realities of Gujarat grid:

1. Majority of open access consumers are on the 66 KV network and SLDC has no grid operation control over 66 KV network. The load demand of consumer is growing rapidly in all segments of consumers. It has net impact on the upstream network of 66 KV and above.

2. The issue is more complex when several gas plants located in strategic locations of heavy load demand are under shutdown. The load flow in the Southern Gujarat network is totally disturbed and existing topology does not work with flow of excess power from upstream network. It is required to be studied by STU to ensure balanced load flow and grid stability.

We also have to recognize that our conventional power stations are quite old and network is required to be studied for various outages and contingencies. There have been instances when we have to run costlier plant in order to serve the STOA consumers.

We have already explained under point (4) & (5) that STOA is being granted for all the eligible applications as per process and there is no intentional delay. It is, therefore, submitted that the State Load Dispatch Centre is acting in accordance with the applicable laws and regulations.

As regards details called for from the State Load Dispatch Centre, it is placed on record that the same were submitted vide communication dated 20th May 2014. A copy of the communication is attached for ready reference. Also any further data is required by Hon'ble Commission, it will be submitted by SLDC.
