**Short Tender Notice No: UGVCL/SP/IV/947/ Hiring of Vehicle Swift Dezire or Equivalent with AC Diesel Car (latest-model) for R&C Office, Mehsana**

Following Clause of tender will be amended as under. All bidders are requested to read this amendment before bidding tender.

**1.PENALTY (RATE):-**

For an absence beyond two hours and up to one day: Rs.1500.00 per Car + 18% GST/Per day.

If the contractor fails to provide the vehicle, the deduction from his RA bill shall be made on prorate considering the monthly rate payable with 26 working days per month **or actual Amount paid by company to hire alternative vehicle.** Whichever is higher.

**Instead of**

For an absence beyond two hours and up to one day: Rs.1500.00 per Car + 18% GST/Per day

If the contractor fails to provide the vehicle, the deduction from his RA bill shall be made on prorate considering the monthly rate payable with 26 working days per month **or actual Amount paid by company to hire alternative vehicle**

**2. FORMULA FOR CONSIDER IN PRICE VARIATION:-**

**Base price of diesel will be price of any PSU oil marketing co. in Mehsana on 15 days before tender submission due date. The price for claiming P/V for Diesel will be price of diesel of Mehsana for the PSU OMC selected above.”**
