GENERAL TERMS AND CONDITIONS OF THE TENDER

Tender for Annual transportation of 8 M/200KG PSC poles from different pole factories under Sabarmati, Himatnagar, Palanpur & Mehsana circle under UGVCL to various SITE locations in UGVCL jurisdiction for year 2021-22.

SCOPE OF WORK

Basically, PSC poles of 8 Mtr/200 kg. type manufactured in pole factories located under jurisdiction of Himatnagar, Sabarmati and Palanpur circle office under the jurisdiction of UGVCL are to be carted to various sites within entire UGVCL area. The tender is invited with separate Price bid for each circle i.e. Sabarmati, Himatnagar, Palanpur & Mehsana. The bidder who wishes to participate in carting of poles for one or more than one circle has to select name of respective Circle from the list in Price bid and has to pay tender fee and EMD for each circle selected. The work will include:

- (1) Loading of poles at Pole Factories (under selected circle) -in-to the trucks. Loading should be done with two point lifting. Single point lifting shall not be allowed.
- (2) Transportation from the pole factories (under selected circle) in-to the trucks.
- (3) Unloading of the poles at work site. Unloading should be done with two points lifting only. Single point lifting shall not be allowed.
- (4) The Bidder should quote the rate against each stage in Price Bid schedule.
- (5) For carting of poles within 00 KM to 30 KM & 30.1 KM to 75KM distance slabs from the pole factory, fixed rate for 00 KM to 30 KM & 30.1 km. to 75 KM per pole will be given as minimum charges per pole respectively. For carting beyond 75 KM distance, rate in Rs. Per Pole per KM will be admissible.
- (6) The location to which the poles are to be transported from the pole factories (under selected circle) shall be decided by the Executive Engineer of the division for the location under their jurisdiction. If required, agency has to unload poles at more than 1 Site location for each trip up to 5 Site locations. In case of carting of poles for more than one SITE location, bill shall be raised for actual KM for each SITE location and payment will be made for actual KM for each SITE location for which carting is done and the distance carted will have to be supported & verified by using Google maps or GPS data sheet made available by the agency along with the bill.
- (7) While issuance of Material requisitions approximate distance between Pole factory and SITE location of unloading of poles will be mentioned. In case of any dispute in claimed KMs and KMs approved by concern authority, the distance shown as per Google map between two SITE locations will be considered as final.
- (8) Dated and time stamped photographs of the poles (to be carted) being loaded in the trucks from the respective pole factories & similarly, photographs of poles being unloaded at intended destination(s) as per MR issued, should also be attached/submitted along with each carting bill for bill processing.
- (9) The transporter has to contact concern sub division officer in advance before carting of poles who may depute their subordinate staff to accompany carting

vehicle so that poles are delivered at correct SITE location and verification of actual KM travelled.

- (10) The rate quoted by the contactors shall be inclusive of loading of poles from any pole factories of circle, Transportation of poles from the factory to the destination within entire UGVCL area as directed by the concern Engineer of the Company and un-loading stacking the same at destination.
- (11) Contractor shall be solely responsible for damages if any occurs to the pole during loading, transporting unloading and stacking the poles at site. The cost of damages to the poles if any shall be recovered from the contractor. The cost of such damages will be fixed by the field officers of the Company in whose jurisdiction the poles are carted. His decision shall be treated as final.
- (12) The contactor shall have to transport poles allotted or as per Material requisition issued every month by different division offices based on allotment of poles from the concerned circle pole factory. The quantities of poles and the destination to which the poles are to be transported shall be fixed by the Company's Officer from time to time.
- (13) **The detailed order shall be placed from respective Circle office.**
- (14) It should be noted that the work amount shown is just for estimate purpose and may vary during execution of orders, however, the quantity shown against the circle shall remain fixed and the work order quantity shall not exceed the respective quantity.
- (15) **Time limit:** The tender pertains to the transportation of 8 M PSC poles of the estimated quantity mentioned in PRICE BID for a period of 12 months or the poles contracted are fully transported, whichever is earlier.
- (16) **Penalty:** Penalty shall be @ 0.5 % per week or part thereof on delayed portion subject to maximum 10 % of the delayed portion order value (End cost) in case of supply only, where as in case of project, the ceiling shall be with reference to total contract value of the project (supply + Erection + Civil). For calculating the delayed portion date of actual carting of poles after stipulated time limit at mentioned site shall be considered.
- (17) Un-carted poles against withdrawal of material requisition will be considered shortfall of quantity for the penalty. Poles should be carted within the stipulated time limit of 30 days from the receipt of Material requisition by the agency. Provided always that the delay in carting by the contractor will be condoned on account of non-availability of PSC poles or due to unforeseen circumstances on his furnishing satisfactory reasons and/or production of documentary proof thereof.
- (18) The payment shall be made by the E.E. of concern Division based on the certificates of the Sub Division Officers for whom the poles are carted. In case of carting of poles for more than one location, bill shall be raised for actual KM for each location and payment will be made for actual KM for each SITE location for which carting is done.
- (19) If the contractor fails to transport poles during any month as directed by the Company's Officers, The UTTAR GUJARAT VIJ COMPANY LIMITED. reserves the right to cancel M.R. pending with contractor for more than one month and Company shall transport these poles through any other agency or departmentally at the risk and cost of the contractor without giving any notice or observing any

formalities in this regards and in that case any expenses that may be incurred in excess of the sum which would have been paid to the original contractor shall be recovered from any un paid amount due to him or from security deposit paid by the contractor and the contractor will have no claim for compensation for any loss sustained by him owing to such action.

- (20) The contractor shall have to enter into an agreement with the Company on stamp paper of appropriate value in the prescribed form whose cost shall be borne by the contractor.
- (21) The general terms and condition of the contract for Works prescribed by the Company in a booklet shall be binding to the contractor and same shall be available in this office during office hours.
- (22) Termination of contract: In case the contractor fails to cart the requisite number of P.S.C. poles as allotted from time to time within the specified period of delivery or any retention thereof the Engineer-in-charge shall exercise his discretionary powers either -
- (1) To recover from contractors damages by way of penalty as stated in earlier clause above or (2) To entrust the work of carting else-where after giving due notice to the contractor & at the risk and cost of the contractor without cancelling the contract in respect of unexecuted work or (3) To rescind the contract & carry out the work under condition No.4 of the booklet of “tender & contract for works” & adopt any of the clauses under (b) & (c) thereof.
- (23) In the event of the Company taking action under clause 2 or 3 stated above, the contractor shall be liable for any loss which the Company may sustain on that account but the contractor shall not be entitled to any gain on such amount made against his default.
- (24) Company may need huge quantity of poles in very short period in special circumstances in that case; Company reserves the right to cart through other carting contractor without informing to contractor to whom the order is placed for particular pole factory.
- (25) In emergency OR unforeseen circumstances, contractor shall have to cart the P.S.C. poles from any other pole factories to any destination of GUJARAT /UGVCL at the same rate & conditions, as and when required on instructions of Engineer in Charge.
- (26) Bidder has to attach List of orders executed in last three years (including works executed in UGVCL) along with copies of satisfactory completion certificate obtained from respective department.
- (27) Bidder has to submit List of works tendered / in hand works along with copies of orders.
- (28) Bidder has to submit EPF certificate.
- (29) Bidder has to give valid Solvency certificate equivalent to 20% of tender value for each Price bid filled up with tender.
