- (1) GI wire No:- 8 CI plate/earthing coil & earthing bolt/M.S. Bolt with nut & washer provided by UGVCL.
- (2) In case of nil stock of earthing bolt, contractor shall have to be provided 2.5X5/8 INCH M.S. nut bolt for connection of GI wire No-8 & CI plate/earthing coil. The market value will be paid to contractor for providing M.S. nut bolt separately.
- (3) Wood charcoal, salt cubes shall be provided by Contractor.
- (4) sundries material like as PVC pipe, bend, shaddle clamp, round lugs shall be provided by contractor as required to cover GINo-8 from ground to metering point. Shaddle clamp shall be providedat an interval of maximum 1 meter distance.
- (5) **One HD rigid PVC pipe provided by UGVCL** to cover GI 8 No from Ground level of Eathing pit.i.e.one earthing one pipe. After that remain open GI 8 no Wire shall be covered by Good Quality of PVC PIPE (electric fitting pipe) and bend having diameter 20 mm & 1.5m.m thickProvided by contractor.
- (6) Work shall be carried out as per instruction of incharge engineer.
- (7) Connection wise A/C of material of CI plate/earthing coil & GI wire No-8 bolt/M.S. Bolt with nut & washer shall be maintained.
- (8) The work should be executed in presence of representative of UGVCL.

: GENERAL INSTRUCTION TO TENDERERS ::

1.0Sealed Tenders are invited for the **Erection of earth terminal of consumer premises, for consumers of Lodra subdivision** office under division office VIJAPUR from the contractors/firms who have executed works of similar nature and magnitude successfully and who are registered under appropriate class.

2.0 Tender documents are in two bids system i.e. "Technical Bid" and "Price Bid".

- **2.1Technical bid** is to be submitted in a separate sealed envelope and supper scribing the envelope as **"Technical Bid"as well as on onsite with scanning.** Technical bid should be submitted with documents as under, failing which tender is liable for rejection.
 - (i) Solvency certificate issued from any Nationalized Bank amounting to sum equivalent of estimated cost (Minimum 5.0 Lacs)
 - (ii) Separate EPF code No. allotted by RPFC & Last Six month of current year EPF Challan paid copy is required.
 - (iii) Registration certificate in appropriate class as contractor in UGVCL /Irrigation/Central Govt. undertaking / state Govt. undertaking/Railway/Semi.Govt..
 - (iv) Latest income tax clearance certificate. With PAN card.
 - (v) Experience :-Contractor should produce evidence of having experience in executing similar nature & magnitude of jobs preferably photo copy of orders secured from UGVCL /Central/ State Government /Railway / Semi Government and satisfactory completion certificate from respective department.& Certificate as per requirement for Erection of earth terminal of consumer premises, for consumers of GOZARIYA subdivision by authorized officer of Distribution Company.
 - (vi) Group Insurance A copy of the insurance policy of the insured laborer's under W.C. Act.
 - (vii) Details of equipments available with the tendered.



- (viii) Electrical contractor license or wireman certificate with engineer registration is required.
- (ix) Tools & tackle Certificate.
- (x) At least Rs. 30 Lacks turn over required in bank Statement(atleast last one year)
- (xi) Copy of the last five annual work orders of erection of HT/LT line & T/C of any Distribution Company is required.
- (xii) GST tax registration no must be submitted with tender .
- (xiii) Tin No is required .

The above documents should be submitted in form of attested true copies along with technical bid.

- **2.2** Both "Technical" and "Price" bid should be submitted in different envelope subscribing the name of the work and tender opening date etc.
- **3.0** Technical bid shall be opened on date -----. at **11.00** hrs. (If possible) in the presence of the bidders, who remains present at that time.
- **4.0** Earnest money deposit of **Rs. 5000.00** should be deposited in form of DD of Nationalized Bank in favor of UTTAR GUJARAT VIJ COMPANY LIMITED drawn on any scheduled Bank, payable at VIJAPUR.

5.0 Bidders should complete the tender documents in all respects and they are to be signed with Company's seal on all pages.

6.0 The bidders shall submit their offer without any deviations in general terms and conditions of the contract or in Technical specification/items. Tenders of such departing, may also be rejected. Incomplete and conditional tenders shall not be considered.

7.0 UTTAR GUJARAT VIJ COM.LTD. reserves the right to split up the work covered in the scope of this contract amongst more than one contractor.

8.0 Intending bidders should submit their tenders after studying all tenders documents carefully and visiting the site for satisfying themselves of actual site



conditions, location and accessibility of site and nature, extent of the work involved etc.

Submission of tenders implies that bidders have obtained all necessary information and other data required for executing the work. No claim for extra charges on account of any misunderstanding or otherwise will be allowed.

10.0 All approaches to the site shall be in the scope of bidders.

11.0 Bidders will not be allowed to give sub-contract of the works awarded to Him for any, reasons what so ever without permission of the Engineer-in charge.

12.0 In the experience certificate, contractor has to furnish the details of similar works executed by him along with the list of equipments, tools and tackles and manpower available with him along with the details of the same, which he intends to deploy on site of the work.

13.0 After opening of "Technical bid" no revised price bid from any bidders will be accepted.

14.0 Price quoted shall be firm, till overall completion of the work, under contract and there will not be any price escalation.

15.0 Date of opening of "Price Bid" will be intimated later on to those Bidders who are qualified in technical bid. "Price bid" of only qualifying bidders on the basis of Technical bid shall only be opened. Price of bidders, who are not qualified technically as per requirement of technical bid shall not be opened.

16.0 Offers shall be valid for the period of 120 days from the date of opening of price bid. Tenders shall not withdraw tenders during the validity period, failing which their EMD shall be forfeited during the said period of 120 days.

17.0 All the works shall be carried out as per specifications attached with the tender and relevant Indian Standard issued by Bureau Indian Standards. All materials procured should be confirming to relevant Indian Standard issued by Bureau of Indian Standard.



18.0 Tenders, which do not fulfill all or any of the conditions of the tender of incomplete in any respect, are liable to rejection.

19.0 UTTAR GUJARAT VIJ COMPANY LTD, reserves the right to reject any or all tenders without assigning any reason thereof.

20.0 Income Tax at prevailing rate will be deducted as per income Tex Act.

21.0 The rates are inclusive of PF and all other State/Central Government Taxes , cess and levies but exclusive of GST tax .GST Tax @prevailing , if applicable will be reimbursed by UGVCL on production of service Tex paid challan.

22.0 Any charge in rate of GST tax shall be entertained during contractual period of contract.

23.0 The Contractor shall pay VAT/Sales tax on material portion and the same will not be reimbursed by UGVCL.

24.0 Moreover contractor shall pay GST tax of his parts on service portion as per prevailing laws.

25.0 The contractor shall disclosed GST tax amount paid by him in the RA / Final bill raised for the execution of the work.

26.0 The copy of GST tax challan paid on previous RA /Final bill should be submitted to UGVCL for reimbursement .

27.0 If any work will not be executed by contractor fully / partly due to non providing of materials by UGVCL, than the amount at appropriate rate will be deducted from the contractors bill, as the amount of non execution of works is already included in the rate of order.

28.0 Terms & condition & other relevant documents is required .29.0 Any dispute of difference arising under this connection with contract shall be subjected th the exclusive jurisdiction of UGVCL, Vijapur Division.
