The rates accepted are for supply F.O.R. at **fixing place consider by sdn & Division engineer in Villages and town places under Mehsana Circle area.** Nothing will be paid extra. The unloading would be on Company's account.
2. Earnest money should be paid in cash and receipt thereof should be attached with the tender. In case tenderer will be failed to execute the contract or fulfill the necessary formalities, the EMD will be forfeited.
3. The successful tenderer whose tender is accepted unquestionably shall have to pay security deposit @ 10% of order value within 10 days from the date of receipt of order; the same is liable to forfeiture by the Company in the event of non-execution of order and non-observance of fulfillment of terms and condition of this contract.
4. Payment will be made after receipt of materials in good condition certified by Recording Officer with adequate satisfaction. Through RTGS before Advance stamped receipt received from you.
5. The entire materials should be supplied within a period of **30 days** from the date of orders. Time factor is very essential; it will be ascertained before we place orders for supply of goods. In case the materials will not be delivered within the period stipulated in the order, you will liable to pay at the discretion of the competent authority, a penalty to the Company up to ½% per week on the price subject to a maximum of 10% reckoned on the order value of such materials. Due consideration will be given in the levy of penalty for reason absolutely beyond your control for which documentary evidence will have to be produced to the satisfaction of the competent authority of the Company.
6. In case the assigned store materials are not found in accordance with prescribed specification and approved sample, the Company shall exercise its discretionary power either to recover from supplier or by way of penalty or to purchase from


