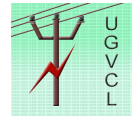

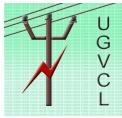

Conditions to Supply of L T AB cable accessories for KADI Division.

1. The rate of material is including all taxes & service charge.
2. The approved specimens of entire supply of the material, with the paper seal duly discharged by the supplier and the UGVCL authority will be kept at UGVCL Division Office. In case of any discrepancies/ litigation arising out of any issue related to the supply; the specimen kept at this office will be taken in to accounts, only.
3. You have to submit all type and routine test certificate of the material supplied by you.
4. UGVCL may send the Sample to ERDA for necessary testing of the sample and if sample failed in testing then all testing charge will be borne by supplier.
5. penalty will be applicable in case of failure of testing sample as per UGVCL norms.
6. Package information: - Each package lot shall be marked with the Manufacture name, Purchase Order, Item description, pack size, packs weight and applicable IS standard.
7. In case of any discrepancy, the E-I-C will provide the guide lines and the contractor will have to follow the same. The discretion of the authority issuing the tender and above will be binding to the contractor.
8. Material should be supply after approval of sample.
9. Quantity for various items of schedule –B may vary during actual order placed.
10. Transportaion and loading unloading of material will be borne by supplier.

1) A. Earnest Money Deposit:

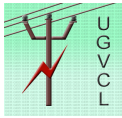
