1. Sealed Tenders are invited for the **Work of Laying of H.T Arial Bunch Cable under various S/Dn Offices Division Office Patan UGVCL** from the contractors/firms who have executed works of similar nature and magnitude successfully.
2. **Date of Demand Draft should not be older than 10 Days from the last date of receiving of tender.**
3. Tender documents are in two bids system i.e. **“Technical Bid”** and **“Price Bid”**.
4. Technical bid is to be submitted in a separate sealed envelope and subscribing the envelope as **“Technical Bid”** & also subscribing the name of the work and tender opening date etc.

Technical bid should be submitted with documents as under, failing which tender is liable for rejection.

- i. Solvency certificate issued from any Nationalized Bank amounting to sum equivalent of estimated cost
- ii. PAN Card
- iii. EPF Registration And EPF Paid Challan copy
- iv. Insurance copy
- v. Latest income tax Return Copy
- vi. Experience certificate of work order as per requirement for the work of laying of HT Arial Bunch Conductor by authorized officer of Distribution Company
- vii. Electrical contractor license if applicable
- viii. Labour license if applicable
- ix. GST Registration if applicable
- x. D.D of Tender Fees & EMD

(Bidders Who Deposit Tender Fees & EMD at UGVCL cash counter Should mention receipt no & date in tender copy)

The above documents should be submitted in form of attested true copies along with technical bid.

5. The sealed price bids comprising of Schedule-‘B’ should be submitted in separate sealed envelope subscribing the envelope as **“Price Bid”**.
6. Both **“Technical”** and **“Price”** bid should be submit in different envelope subscribing the name of the work and tender opening date etc.
7. **Failing submission of any of one bid cause for rejection of tender.**
8. **Envelope without subscribing “Name of Bid” will not be accepted & Tender will be rejected.**

9. The bidders shall submit their offer without any deviations in general terms and conditions of the contract or in Technical specification/items. Tenders of such deviations may also be rejected. Incomplete and conditional tenders shall not be considered.
10. The rates shall be quoted both in words and figures as per unit specified in schedule-'B' in case of any discrepancy between the rates quoted in words & figures, rate quoted in words will prevail.
11. Intending bidders should submit their tenders after studying all tenders documents carefully and visiting the site for satisfying themselves of actual site conditions, location and accessibility of site and nature, extent of the work involved etc. Submission of tenders implies that bidders have obtained all necessary information and other data required for executing the work.
12. "Price bid" of only qualifying bidders on the basis of Technical bid shall only be opened. Price of bidders, who are not qualified technically as per requirement of technical bid shall not be opened.
13. Bidder should work in presence's of supervisor.
14. Bidder should observe all the safety rules during work. Contractor is responsible for any type of Accident/Damage
15. **Work may be allotted by EIC as & when it is require.**
16. The supplied materials should have long shelf life, at least of 1 year. In case of any of the item goes degraded, the supplier shall be required to replace the same, at his cost and risk. **Security deposit will be refundable after the completion of this guarantee period.**
17. **Penalty clause: in case, the work is not completed within the period stipulated in the sub work order, penalty shall be levied at 0.5 per week on the total sub work order subject to maximum 10 % of respective sub work order.**
18. After completion of work, inspection may be carry out by Division/SDn office and any of the supplied items or work found of inferior quality, shall be liable for rejection of the entire work.
19. All the works shall be carried out as per company standard specifications & work quantity may be increase or decrease during actual work within order amount.
20. Tenders, which do not fulfill all or any of the conditions of the tender of incomplete in any respect, are liable to rejection.
