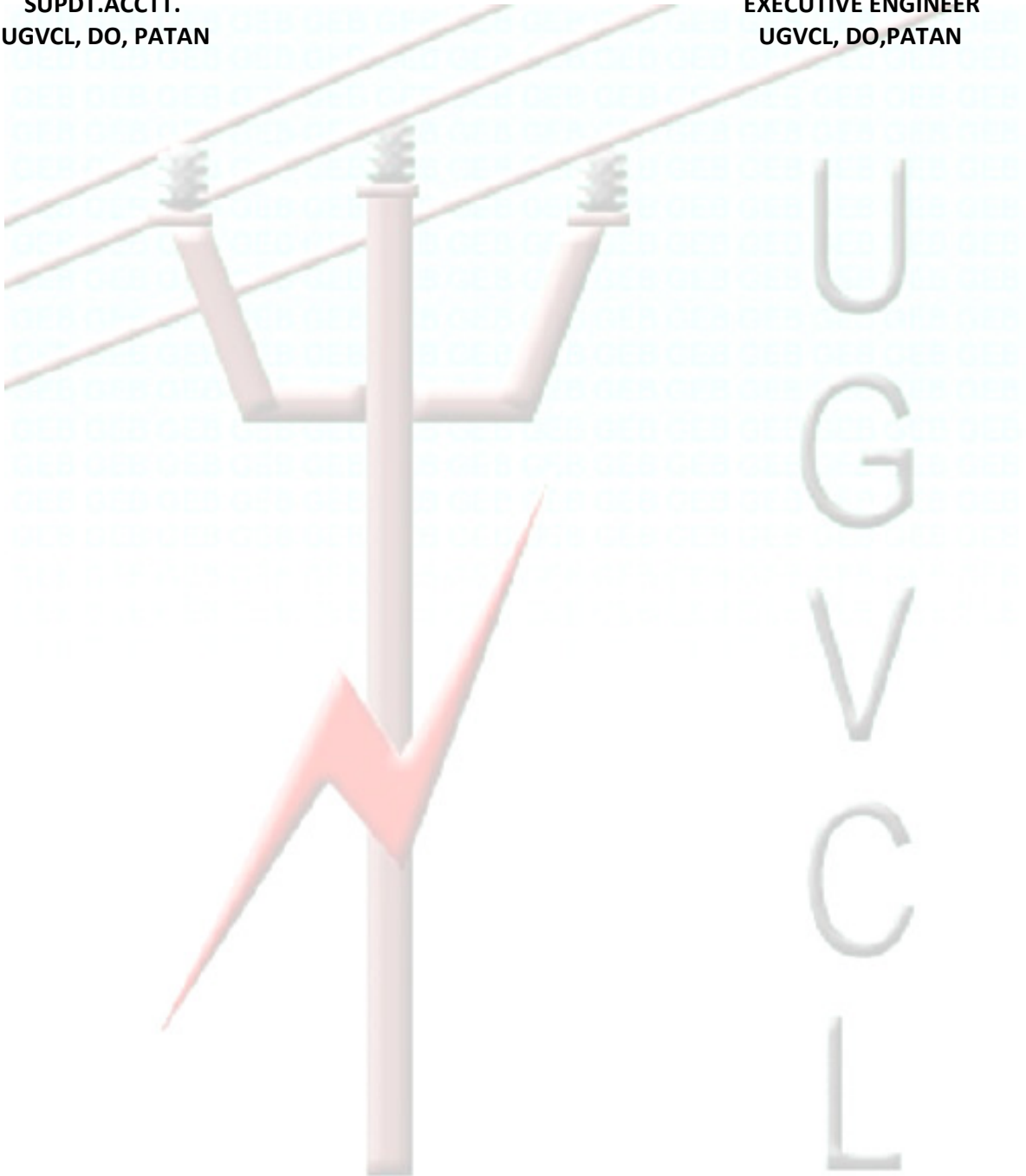

1. Sealed Tenders are invited for the work of repairing of old/damage/burnt A.B switches from the contractors/firms who have executed works of similar nature and magnitude successfully.
2. Date of Demand Draft should not be older than 15 Days from the last date of receiving of tender.
3. Tenders are in two bids system i.e. “Technical Bid” and “Price Bid”.  
Technical bid should be submitted with documents as under, failing which tender is liable for rejection.
  - a. PAN Card
  - b. GST Registration if applicable
  - c. D.D of Tender Fees & EMD  
(Bidders Who Deposit Tender Fees & EMD at UGVCL cash counter should mention receipt no & date in tender copy)The above documents should be submitted in form of attested true copies along with technical bid.
4. The sealed price bids comprising of Schedule-‘B’ should be submitted in separate sealed envelope subscribing the envelope as “Price Bid” & also subscribing the name of the work and tender opening date etc.
5. **Bidder must submit both Technical Bid & Price Bid separately. Failing any of one bid cause for rejection of tender.**
6. Envelope without subscribing “Price Bid” or “Technical Bid” will not be accepted & Tender will be rejected.
7. The bidders shall submit their offer without any deviations in general terms and conditions of the contract or in Technical specification/items. Tenders of such deviations may also be rejected. Incomplete and conditional tenders shall not be considered.
8. Intending bidders should submit their tenders after studying all tenders documents carefully and visiting the site for satisfying themselves of actual site conditions, location and accessibility of site and nature, extent of the work involved etc. Submission of tenders implies that bidders have obtained all necessary information and other data required for executing the work.
9. UGVCL Patan will supply Old/Damage/Burnt A.B Switches or M S Channel at your work site & collect the ready material from your site.

10. Bidder has to repair or convert A.B Switches by providing & fixing Male Contacts, Female Contacts, Insulators , Nut Bolts etc
11. Bidder should provide & fix Composite Insulators (if require) as per instruction of concern Engineer incharge.
12. **Penalty clause:** in case, the work is not completed within the period stipulated in the sub work order, penalty shall be levied at 0.5 per week on the total sub work order subject to maximum 10 % of respective sub work order plus 18% GST.
13. Bidder fail to work, security deposit will be forfeited.
14. All the works shall be carried out as per company standard specifications & work quantity may be increase or decrease during actual work within order amount.
15. If material/part of material found inferior quality, whole material lot will be rejected & bidder has to replace by his own risk & cost
