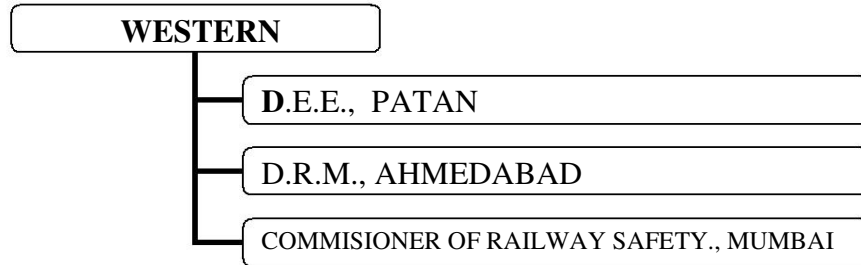

## SITE EXECUTION TERMS & CONDITIONS

- PERMISSION TO CARRY OUT THE WORK AT SITE WILL BE ALLOWED ONLY AFTER THE WRITTEN PERMISSION FROM THE OFFICE OF:



1. THE CONTRACTOR SHALL CONSIDER THE SITE CONDITIONS OF UNDERGROUND CABLE LAYING WORK BEFORE QUOTING THE OFFER
2. CONTRACTOR SHALL HAVE TO STRICTLY FOLLOW ALL THE INSTRUCTIONS TERMS AND CONDITIONS OF CONCERNED RAILWAY AUTHORITIES AND THE CONDITIONS LAID BY THE RAILWAYS IN THERE APPROVED DRAWINGS AT THE TIME OF EXECUTION OF WORK.
3. AS MENTIONED IN ITEM ALSO CONTRACTORS HAVE TO CARRY OUT THE WORK USING HORIZONTAL AUGER BORING MACHINE.
4. NO MANUAL BORING IN ANY CASE WILL BE ALLOWED. USING OTHER METHOD INSTEAD OF AUGER BORING MACHINE WILL NOT BE ALLOWED AND WILL BE CONSIDERED AS VOID OF CONTRACT TERMS AND CONDITIONS.

LOOPING OF CABLE IS TO BE DONE IN THE GROUND BELOW DP STRUCTURE BY EXCAVATING EARTH AND APPROXIMATELY 06 METERS OF LOOPING TO BE LAID IN THE EXCAVATED EARTH ON BOTH SIDES, AFTER WHICH THE SAME SHALL BE FILLED WITH SAND AND WARNING BRICKS SHALL BE PROVIDED ON CABLE FOR WHICH NO EXTRA PAYMENT WILL BE MADE.
