

- 3. Tender documents are in two bids system i.e. "Technical Bid" and "Price Bid".
- 4. Technical bid is to be submitted in a separate sealed envelope and subscribing the envelope as" **Technical** Bid".

Technical bid should be submitted with documents as under, failing which tender is liable for rejection.

- a. Solvency certificate issued from any Nationalized/Scheduled Bank amounting to sum equivalent of estimated cost

- 11. Penalty clause: in case, the work is not completed within the period stipulated in the sub work order, penalty shall be levied at 0.5 per week on the total sub work order subject to maximum 10 % of respective sub work order plus applicable GST.
- 12. Bidder should work in presence's of supervisor.
- 13. Bidder should observe all the safety rules during work. Contractor is responsible for any type of Accident/Damage
- 14. The supplied materials should have long shelf life, at least of 1 year. In case of any of the item goes degraded, the supplier shall be required to replace the same, at his cost and risk.
- 15. After completion of work, inspection may be carry out by Division/SDn office and any of the supplied items or work found of inferior quality, shall be liable for rejection of the entire work. If require, Earthing resistance will be measure and it should be < 5 ohm.
- 16. Work may be allotted by E.I.C as & when it is require. Successful Bidder is bound to work under any S/Dn of Division Office Patan .
- 17. All the works shall be carried out as per company standard specifications & work quantity may be increase or decrease during actual work within order amount.
