1	<p>Labour charges for Erection of G.I Pipe type Earthing of First Thirty poles on 11kv feeders.</p> <p>Each earthing shall be provided by digging a pit of minimum Size (1800 X 200 X 200) mm. The pit shall be at least 1200 mm far from the Poles. The contractor shall lower the G.I Pipe to the pit and make connection to the GI Strip with suitable GI nuts & bolts. Contractor has to make the connection of GI Strip to the fabrication material fitted on Pole by GI Wire No.8 SWG. The pit will be filled in by alternate layers of wood charcoal and salt cubes each of 30 cms till the 1500 mm from bottom. Remaining 300mm shall be refilled by earth dug out.</p> <p>Note :- The contractor shall have to provide 10Kg wood charcoal, 10Kg salt cubes and sundries materials (like Shadal clamp & GI Wire No.8 SWG, G.I Nut-Bolts Etc) on his own.</p>	690	Number	350	241500

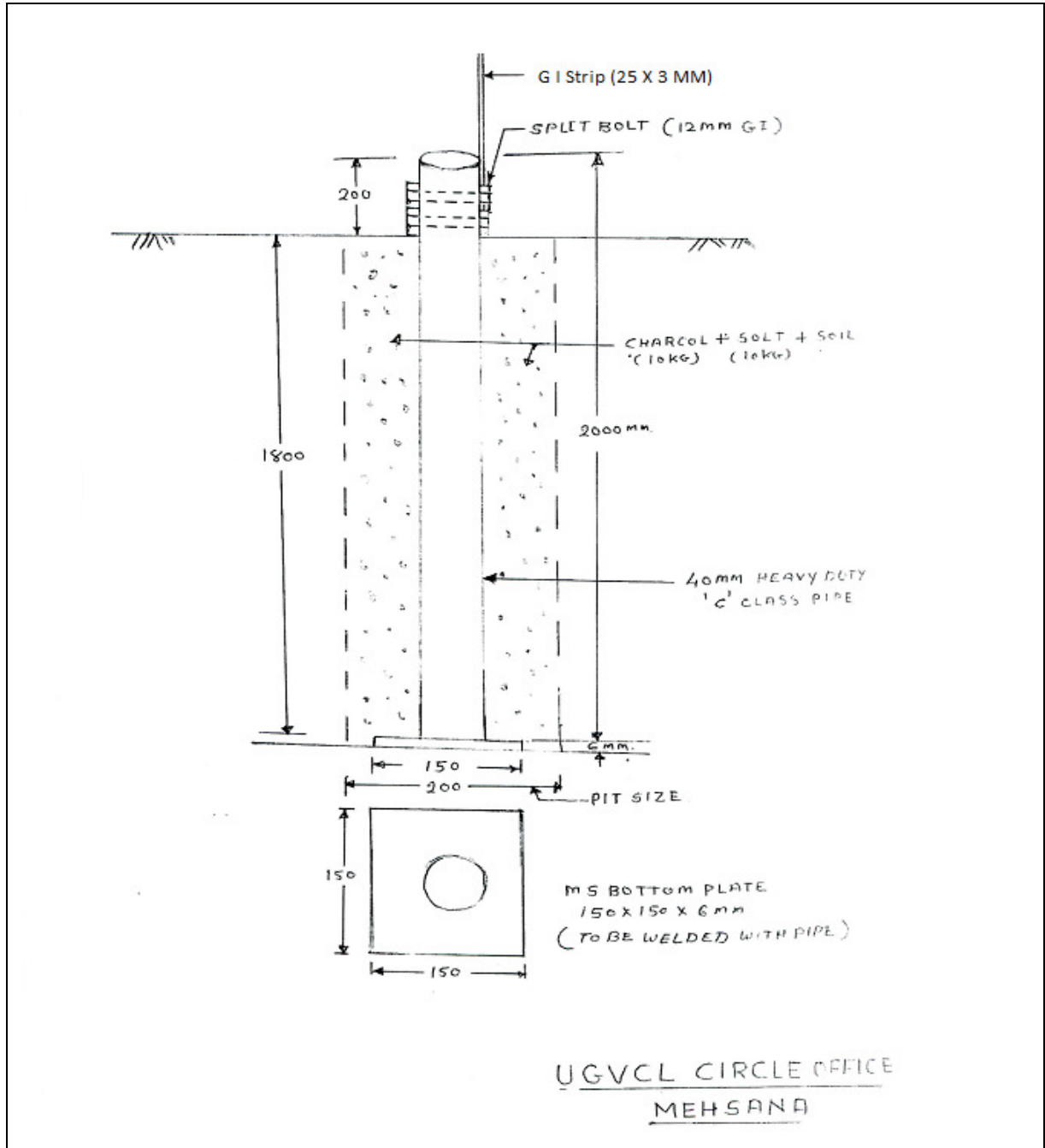

GENERAL INSTRUCTION TO TENDERERS

Sealed Tenders are invited from the contractors/firms who have executed works of similar nature and magnitude successfully.

1. **Date of Demand Draft should not be older than 15 Days from the last date of receiving of tender. If D.D is older & its due date is over or bank not accept the same due to any reason at the time of opening of Technical Bid, authority may reject your tender.**
2. Tender documents are in two bids system i.e. “**Technical Bid**” and “**Price Bid**”.
3. Technical bid is to be submitted in a separate sealed envelope and subscribing the envelope as “**Technical Bid**”.

Technical bid should be submitted with documents as under, failing which tender is liable for rejection.

- a) Solvency certificate issued from any Nationalized/Shehuled Bank amounting to sum equivalent of estimated cost
- b) PAN Card
- c) EPF Registration And EPF Paid Challan copy
- d) Insurance copy
- e) Work Experience certificate for similar Type Earthing with material supply & labour work issued by authorized officer of Distribution Company under GUVNL. Experience certificate should be of Rs.5 Lacs amount minimum & mentioned with work order number & date and work completion date etc. If require this office may ask to submit work order copy & its work completion certificate also.
- f) Electrical contractor license if applicable
- g) Labour license if applicable
- h) Vendor Registration Certificate in **appropriate class** as a contractor Under GUVNL Or its subsidiary company
- i) GST Registration If applicable

The above documents should be submitted in form of self attested true copies along with technical bid.

4. **Bidder must submit Technical Bid at division office Patan UGVCL with all necessary documents in a separate sealed envelope** and subscribing the envelope as “**Technical Bid**” & also subscribing the name of the work and tender opening date etc. Technical Bid shall open manual at Division Office

Patan UGVCL. Envelope without subscribing “Technical Bid”& Other Detail will not be accepted & Tender will be rejected.

5. **The Bidder must submit their price bid online on N-Procure web site only.** “Price bid” of only qualifying bidders on the basis of Technical bid shall only be opened **online** at Division Office Patan UGVCL. Price of bidders, who are not qualified technically as per requirement of technical bid shall not be opened.
6. **Failing submission of any of one bid cause for rejection of tender.**
7. The bidders shall submit their offer without any deviations in general terms and conditions of the contract or in Technical specification/items. Tenders of such deviations may also be rejected. Incomplete and conditional tenders shall not be considered.
8. Intending bidders should submit their tenders after studying all tenders documents carefully and visiting the site for satisfying themselves of actual site conditions, location and accessibility of site and nature, extent of the work involved etc. Submission of tenders implies that bidders have obtained all necessary information and other data required for executing the work.
9. “Price bid” of only qualifying bidders on the basis of Technical bid shall only be opened. Price of bidders, who are not qualified technically as per requirement of technical bid shall not be opened.
10. **Successful Bidder is bound to work under any S/Dn of Division Office Patan if require. Concern authority may transfer your total/partial order to any S/Dn of Division Office Patan & Bidders is bound to work there with the same rate, conditions & without any type of extra charges.**
11. **Penalty clause: in case, the work is not completed within the period stipulated in the sub work order, penalty shall be levied at 0.5 per week on the total sub work order subject to maximum 10 % of respective sub work order plus applicable GST.**
12. Contractor should work in presence of supervisor of UGVCL.
13. Contractor should observe all the safety rules during work. Contractor is responsible for any type of Accident/Damage
14. After completion of work, inspection may be carry out by Division/SDn office and work found of inferior quality, shall be liable for rejection of the entire work. **If require, Earthing resistance will be measure and it should be < 5 ohm.**
15. All the works shall be carried out as per company standard specifications , terms & conditions and work quantity may be increase or decrease during actual work within order amount.
16. Tenders, which do not fulfill all or any of the conditions of the tender of incomplete in any respect, are liable to rejection.
