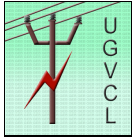

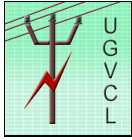

2. **Date of Demand Draft should not be older than 15 Days from the last date of receiving of tender. If D.D is older & its due date is over or bank not accept the same due to any reason at the time of opening of Technical Bid, authority may reject your tender.**
3. Tenders are in two bids system i.e. **“Technical Bid”** and **“Price Bid”**.

Technical bid should be submitted with documents as under, failing which tender is liable for rejection.

- a. Ownership documents of properties & Other Relevant Documents

After opening of technical bid If any related document (out of above list) require, it will be demand by UGVCL & bidder is bound to provide the same within stipulated time.

The above documents should be submitted in form of attested true copies along with technical bid.

4. The sealed price bids comprising of Schedule-‘B’ should be submitted in separate sealed envelope subscribing the envelope as **“Price Bid”**.
5. **Both “Technical” and” Price” bid should be submit in different envelope subscribing the name of the work and tender opening date etc.**
6. **Failing submission of any of one bid cause for rejection of tender.**
7. The bidders shall submit their offer without any deviations in general terms and conditions of the contract or in Technical specification/items. Tenders of such deviations may also be rejected. Incomplete and conditional tenders shall not be considered.

9. Tenders, which do not fulfill all or any of the conditions of the tender of incomplete in any respect, are liable to rejection.



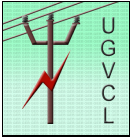

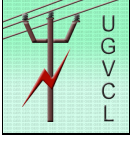
