1	9902040002	Labor charges for providing earth terminal at the consumer premises. Scope of work:- (1) Each earth terminal shall be provided by digging a pit of 1800mm x 600mm x 600mm. The pit shall be at least 1200mm far from the nearest support. The contractor shall lower the earthing coil/ C I plate provided by the company to the pit and make connection through to the external terminal of the metering point. The pit will be filled in by alternate layers of wood charcoal and salt cubes each of 30cms till the 1500MM from bottom or will be filled by betonies powder. Remaining 300mm shall be refilled by earth dug out. The contractor shall have to provide Wood charcoal (10 KG approx.) and the salt cubes (10 KG approx.) or betonies powder (25 KG approx.) his own. - (1) GI wire No:- 8 CI plate/earthing coil & earthing bolt/M.S. Bolt with nut & washer provided by UGVCL.
- (2) In case of no availability of earthing bolt, contractor shall have to be provided 2.5X5/8 Inch M.S. nut bolt for connection of GI wire No-8 & CI plate/earthing coil. The market value will be paid to contractor for providing M.S. nut bolt separately.
- (3) Wood charcoal, salt cubes shall be provided by Contractor.
- (4) Sundries material like as PVC pipe, bend, saddle clamp, round lugs shall be provided by contractor as required to cover GI No-8 from ground to metering point. Saddle clamp shall be provided at an interval of maximum 1.5 fit distance.

B). **PRICES:** - The Bidder shall quote FIRM PRICES only. The prices quoted will not be subject to any escalation till completion work. The above prices are inclusive of all taxes, levies, Duties etc. except Goods & Service Tax (GST) will be paid extra as applicable from time to Time on a given taxable goods and/or services. Also please mention **SAC Code** and rate of GST as Applicable.

#### **C).GOODS& SERVICE TAX(GST):- UGVCL GST No. is:-24AAACU6551F1Z1**

The firm prices are exclusive of Goods & service Tax as applicable. The amount and rate (%) of GST as applicable should clearly be indicated separately. (GST means all applicable Tax/cess under GST laws. GST Laws means IGST Act, GST (Compensation to the State for Loss of Revenue) Act CGST Act, UTGST Act and SGST Act-2017 and all related ancillary legislations). Contractor should charge GST in invoice at the rate as agreed to/mentioned in acceptance of tender only any deviation in the same shall not be accepted. STATUTORY VARIATION:-**Any statutory increase or decrease in GST as applicable or in the event of introduction of new tax/cess or cessation of existing tax/cess subsequent to the offer if it takes place within the original contractual completion date will be to Company's account subject to the claim being supported by documentary evidence. However, if any decrease takes place after the contractual delivery date, the advantage will have to be passed on to COMPANY.

**E). PENALTYS FOR DELAYS:-**The delivery, erection and commissioning periods (as applicable) shall be guaranteed under penalty clause mentioned below. 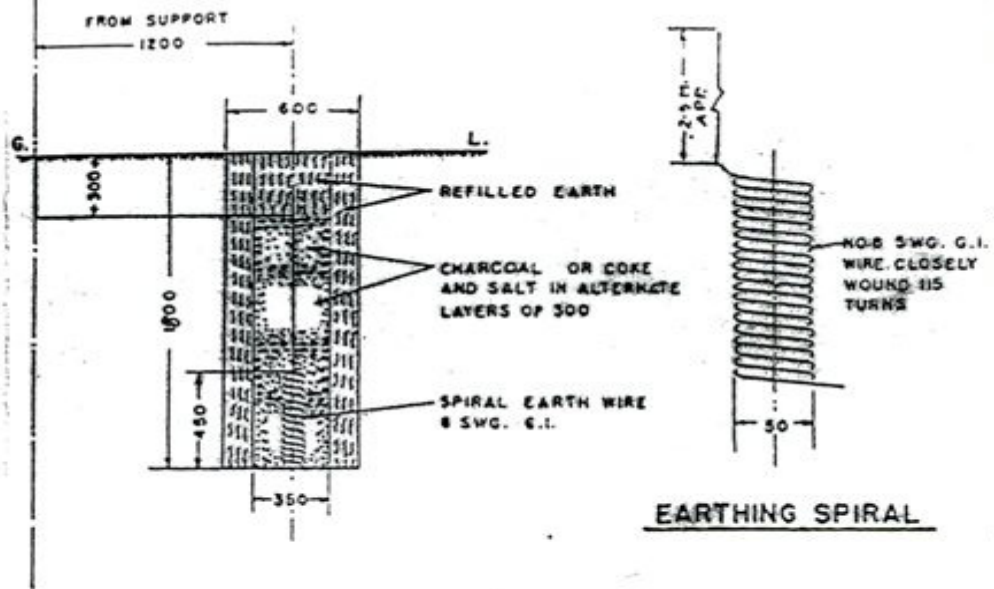
