# <u>The Annual maintenance contract will include the following</u> <u>conditions:</u>

- 1. It is ordinary annual maintenance contract. It will include the labour charges of gas refilling/recharging, also. However, the material cost if any, will be paid by concern office of UGVCL separately.
- 2. The contractor will attend all the calls, whatever be the reason and condition. If needed, he will be required to work on a Sunday/Holiday for attending the faults.
- 3. The contractor will have to offer the guarantee of at least 1 year, for the compressors replaced by him.
- 4. The contractor will have to replace any part of a faulty air conditioner like sensor, remote, tubing, filters, drivers, etc. to put the Air conditioner back in working condition.
- 5. The contractor will submit the report in writing with all his running and final bill regarding the amperes loading of all the machines; before and after each service.
- 6. As recommended by the manufacturers of the A/C machines, the contractor will have to apply wet service at all the scheduled services.
- 7. The payment of the contract value will be paid in four instalments falling at the end of each quarter.

- (i) Separate EPF code No. allotted by RPFC & Last Six month of current year EPF Challan Paid Copy is required.
- (ii) Income Tax & GST :
  - a. Latest income tax clearance certificate for the year 2018-19 And/or 2019-20
  - b. Income tax at prevailing rate will be deducted as per income tax act
  - c. Regarding conditions of Tax, it will be binding to the contractor at relevant times.
  - d. The Rate is Mention in Schedule B is without GST.
  - e. Contracter do Mention Clerly GST in Schedule B.
- (iii) Group Insurance copy of the insurance policy of the insured labourer's under W.C. Act.
- (iv) Electrical contractor license.
- (v) Experience certificate/ work order of servicing of the Air conditioning Machines in Govt / under taking company of Govt with amounting to minimum Rs. 2.00 Lacs totalling during last F.Y 2017-18-19 AND/OR up the end of previous month of inviting this tender in current year 2019-20.
