- 1. Sealed Tenders are invited for the work of **Replacement of Distribution Transformer** from the contractors/firms who have executed works of similar nature and magnitude successfully.
- 2. Date of Demand Draft should not be older than 15 Days from the last date of receiving of tender. If D.D is older & its due date is over or bank not accept the same due to any reason at the time of opening of Technical Bid, authority may reject your tender.
- 3. Tender documents are in two bids system i.e. "Technical Bid" and "Price Bid".
- 4. Technical bid is to be submitted in a separate sealed envelope and subscribing the envelope as"

  Technical Bid".

Technical bid should be submitted with documents as under, failing which tender is liable for rejection.

- a. Solvency certificate issued from any Nationalized/Scheduled Bank amounting to sum equivalent of estimated cost
- b. PAN Card
- c. EPF Registration And EPF Paid Challan copy
- d. Insurance copy
- e. Latest income tax Return Copy
- f. Minimum 3 year of similar work Experience certificate with work order & work completion certificate issued by authorized officer of Distribution Company
- g. Electrical contractor license if applicable
- h. Labour license if applicable
- i. Vendor Registration Certificate in appropriate class as a contractor Under GUVNL Or its subsidiary company
- j. GST Registration If applicable

The above documents should be submitted in form of attested true copies along with technical bid.



- 5. The sealed price bids comprising of Schedule-'B' should be submitted in separate sealed envelope subscribing the envelope as "Price Bid" & also subscribing the name of the work and tender opening date etc.
- 6. Bidder must submit both Technical Bid & Price Bid separately. Failing any of one bid cause for rejection of tender.
- 7. Envelope without subscribing "Price Bid" or "Technical Bid" will not be accepted & Tender will be rejected.
- 8. "Price bid" of only qualifying bidders on the basis of Technical bid shall only be opened. Price of bidders, who are not qualified technically as per requirement of technical bid shall not be opened.
- 9. The bidders shall submit their offer without any deviations in general terms and conditions of the contract or in Technical specification/items. Tenders of such deviations may also be rejected. Incomplete and conditional tenders shall not be considered.
- 10. Tenders, which do not fulfill all or any of the conditions of the tender of incomplete in any respect, are liable to rejection.
- 11. The rates shall be quoted both in words and figures as per unit specified in schedule-B. In case of any discrepancy between the rates quoted in words & figures, rate quoted in words will prevail.
- 12. Intending bidders should submit their tenders after studying all tenders documents carefully and visiting the site for satisfying themselves of actual site conditions, location and accessibility of site and nature, extent of the work involved etc. Submission of tenders implies that bidders have obtained all necessary information and other data required for executing the work.
- 13. Bidder fail to work, security deposit will be forfeited.
- 14. Installation of Transformer should be complete with wiring also.
- 15. All the works shall be carried out as per standard specifications & as per instruction of Engineer in Charge.
- 16. The Work Quantity may be increase or decrease during actual work within order amount.
- 17. Contractor has to provide necessary instrument like vehicle with full insurance & its relevant documents renewed from time to time, chain pulley block etc for the replacement of distribution transformer.
- 18. For the replacement of distribution transformer only one line staff will be provide from concern s/dn to take Line Clearance



- 19. Contractor has to collect MR , CR , Consumer Detail, Transformer Detail etc from concern s/dn office at every morning 09.00 HRS
- 20. Division Store timing is 10.30 HRS to 18.10 HRS. So contractor should collect or credit transformer with necessary documents like MR/CR during this time of office working days only.
- 21. If necessary, contractor has to replace distribution transformer on holidays also. Which detail should be collect from concern s/dn as per sr. no.6
- 22. Contactor has to replace Transformer within 24 Hours after getting necessary documents from concern s/dn office. And also Failed Transformer has to be credited within 24 Hours from the date & time of replacement otherwise an amount of Rs. 100/- per day shall be deducted as penalty. If no of fail transformers is higher, contractor has to hire more vehicle & labour to replace the fail Transformer within 24 Hours
- 23. In case if the work is not completed within time limit than necessary arrangement will be done by s/dn officer and its cost will be recover from your bill.
- 24. Contractor is responsible for any type of accident during Transformer replacement/Carting/Loading/Unloading Etc. If any damage to UGVCL property, UGVCL may recover from contractor Bill.
- 25. Income Tax at prevailing rate will be deducted as per Income Tax Act.
- 26. An Agreement on stamp paper of Rs 100 should be execute with UGVCL that if any transformer stolen during lifted division store to installation at consumer premises , contractor is responsible for that & amount will be recover from contractor.
- 27. Any dispute of difference arising under this connection with contract shall be subject to the exclusive jurisdiction of UGVCL PATAN Division.
- 28. In case of any dispute regarding work or any other defect found. The undersigned will Have full right to stop payment in case of unsatisfactory work and that will bind to the Contractor.
- 29. Commercial & Technical Specifications of the work stated in subject are as per UGVCL & Formerly GEB norms and conditions.
