Conditions to Supply of Eye hook for HT AB Cable for Divisions under Mehsana CO

1. Material should be supply after approval of sample.

2. The approved sample specimens of entire supply of the material, with the paper seal duly discharged by the supplier and the UGVCL authority will be kept at UGVCL Division Office. In case of any discrepancies/ litigation arising out of any issue related to the supply; the specimen kept at this office will be taken in to accounts, only.

3.Package information: - Each package lot shall be marked with the Manufacture name, Purchase Order, Item description, pack size, packs weight and applicable IS standard. (not with oil immersed) 4.In case of any discrepancy, the E-I-C will provide the guide lines and the Bidder will have to follow the same. The discretion of the authority issuing the tender and above will be binding to the Bidder.

5.Bidder shall submit Technical bid & Price bid in separate cover. And this two bid submit in one cover also.

6.Bidder must have to submit sample along with the tender. Tender without sample is liable to rejected.

7. The rate of material is excluding all GST & service charge

8. Material should be supplied at division Store free of cost. within time limit.
