- 3. The contractor will have to offer the guarantee of at least 1 year, for the compressors replaced by him.
- 4. The contractor will have to replace any part of a faulty air conditioner like sensor, remote, tubing, filters, drivers, etc. to put the Air conditioner back in working condition.
