- 1>> Sealed Tenders are invited from the contractors/firms who have executed works of similar nature and magnitude successfully.
- 2>> Date of Demand Draft should not be older than 15 Days from the last date of receiving of tender. If

DD is not accept by Bank due to time bar or any other reason, Tender may be reject by authority.

- 3>> Tender documents are in two bids system i.e. "Technical Bid" and "Price Bid".
- 4>> Technical bid is to be submitted in a separate sealed envelope and subscribing the envelope as "Technical Bid".

Technical bid should be submitted with documents as under, failing which tender is liable for rejection.

- a) PAN Card
- b) Insurance copy
- c) Work Experience certificate for similar Type Earthing with material supply & labor work issued by authorized officer of Distribution Company under GUVNL
- d) Electrical contractor license if applicable
- e) Labor license if applicable
- f) Vendor Registration Certificate in appropriate class as a contractor Under GUVNL or its subsidiary company
- g) GST Registration Certificate If applicable

The above documents should be submitted in form of self-attested true copies along with technical bid.

5>> The sealed price bids comprising of Schedule-'B' should be submitted in separate sealed envelope

Subscribing the envelope as "Price Bid".

6>> Both "Technical" and" Price" bid should be submit in different envelope subscribing the name of the

Work and tender opening date etc.

- 7>> Failing submission of any of one bid cause for rejection of tender.
- 8>> "Price bid" of only qualifying bidders on the basis of Technical bid shall only be opened. Price of bidders, who are not qualified technically as per requirement of technical bid shall not be opened.

- 9>> The bidders shall submit their offer without any deviations in general terms and conditions of the contract or in Technical specification/items. Tenders of such deviations may also be rejected. Incomplete and conditional tenders shall not be considered.
- 10>> The rates shall be quoted both in words and figures as per unit specified in schedule-'B' in case of any discrepancy between the rates quoted in words & figures, rate quoted in words will prevail.
- 11>> Intending bidders should submit their tenders after studying all tenders documents carefully and visiting the site for satisfying themselves of actual site conditions, location and accessibility of site and nature, extent of the work involved etc. Submission of tenders implies that bidders have obtained all necessary information and other data required for executing the work.
- 12>> "Price bid" of only qualifying bidders on the basis of Technical bid shall only be opened. Price of bidders, who are not qualified technically as per requirement of technical bid shall not be opened.
- 13>> Successful Bidder is bound to work under any S/Dn of Division Office Vijapur. Concern authority may transfer your total/partial order to any S/Dn of Division Office Vijapur & Bidders is bound to work there with the same rate, conditions & without any type of extra charges.
- 14>> Earnest money deposit will be forfeited in case the successful tender after his tender has been accepted fail to pay the prescribed security deposit and executes the contractor on a non-judicial stamp of appropriate value on his own cost and sign.
- 15>> Validity of Tenders :- All tenders shall be open for acceptance by the company for a period of 90 days from the date of opening the tenders and may be further extended to 30 days if required and the tenders shall be bound to execute the work on acceptance of his tender with in this period
- 16>> Acceptance :- The Company does not bind itself to accept the lowest or any tender neither will any reason be assigned for the rejection. It is also not binding on the company to disclose any analysis reports on the tender.
- 17>> Accepting authority reserves the right of rejection of any of all tenders without assigning any reason thereof.
- 18>> Security Deposit the lowest tender whose tender is accepted shall have to pay 5% security deposit of the tender cost out of which 20% is payable in cash within 8 days from the receipt of the acceptance order and balance 20% will be recovered from the two R.A. Bill or in the first and final bill.
- 19>> Penalty clause: in case, the work is not completed within the period stipulated in the sub work order, penalty shall be levied at 0.5 per week on the total sub work order subject to maximum 10 % of respective sub work order.
- 20>> Contractor should work in presence of supervisor of UGVCL.

- 21>> Contractor should observe all the safety rules during work. Contractor is responsible for any type of Accident/Damage
- 22>> The supplied materials should have long shelf life, at least of 1 year. In case of any of the item goes degraded, the supplier shall be required to replace the same, at his cost and risk. Security deposit will be refundable after the completion of this guarantee period.
- 23>> If you fail to work within time limit your security deposit will be forfeited.
- 24>> After completion of work, inspection may be carry out by Division/SDn office and any of the supplied items or work found of inferior quality, shall be liable for rejection of the entire work. If require, Earthing resistance will be measure and it should be < 5 ohm.
- 25>> Work may be allotted by EIC as & when it is require. Successful Bidder is bound to work under any S/Dn of Division Office Vijapur if require. Concern authority may transfer your total/partial order to any S/Dn of Division Office Patan & Bidders is bound to work there with the same rate, conditions & without any type of extra charges.
- 26>> Penalty clause: in case, the work is not completed within the period stipulated in the sub work order, penalty shall be levied at 0.5 per week on the total sub work order subject to maximum 10 % of respective sub work order plus applicable GST.
- 27>> All the works shall be carried out as per company standard specifications & work quantity may be increase or decrease during actual work within order amount.
