- 3. Tender documents are in two bids system i.e. "Technical Bid" and "Price Bid".
- 4. Technical bid is to be submitted in a separate sealed envelope and subscribing the envelope as "Technical Bid".

Technical bid should be submitted with documents as under, failing which tender is liable or rejection.

- a. PAN Card
- b. GST Registration certificate if applicable
- c. D.D of Tender Fees & EMD

(Bidders Who Deposit Tender Fees & EMD at UGVCL cash counter should mention receipt no & date in tender copy)

The above documents should be submitted in form of attested true copies along with technicalbid.

- 5. The sealed price bids comprising of Schedule-'B' should be submitted in separate sealed envelope subscribing the envelope as "Price Bid".
- 6. Both "Technical" and" Price" bid should be submit in different envelope subscribing the name of the work and tender opening date etc.
