2. **Date of Demand Draft should not be older than 15 Days from the last date of receiving of tender.**
3. Tenders are in two bids system i.e. **“Technical Bid”** and **“Price Bid”**.

Technical bid should be submitted with documents as under, failing which tender is liable for rejection.

- a. Solvency certificate issued from any Nationalized/Scheduled Bank amounting to sum equivalent of estimated cost
- b. PAN Card
- c. GST Registration if applicable
- d. D.D of Tender Fees & EMD
(Bidders Who Deposit Tender Fees & EMD at UGVCL Patan Cash Window Should mention receipt no & date in tender copy)
- e. Latest income tax Return Copy
- f. Labour license
- g. Copy of the Electrical contractor license
- h. Vendor Registration Certificate in any class as a contractor Under GUVNL or its subsidiary company

The above documents should be submitted in form of attested true copies along with technical bid.

4. **The sealed price bids comprising of Schedule-‘B’ should be submitted in separate sealed envelope subscribing the envelope as “Price Bid” & also subscribing the name of the work and tender opening date etc.**

10. Contractor is responsible for any type of accident during Transformer replacement/Carting/Loading/Unloading Etc. If any damage to UGVCL property, UGVCL may recover from contractor Bill. The contractor will have to under taken responsibility of accidents etc. for his persons working on the line and same will be on notarized stamped paper of Rs.300/- or the appropriate value (if revised by Gove) in case of contract awarded. The cost of stamped will be borne by contractor.
11. An Agreement on stamp paper of Rs 300 should be execute with UGVCL that if any material stolen during lifted division store to installation at consumer premises, contractor is responsible for that & amount will be recover from contractor.
12. The rates shall be quoted both in words and figures as per unit specified in schedule-'B' in case of any discrepancy between the rates quoted in words & figures, rate quoted in words will prevail.
13. Intending bidders should submit their tenders after studying all tender's documents carefully and visiting the site for satisfying themselves of actual site conditions, location and accessibility of site and nature, extent of the work involved etc. Submission of tenders implies that bidders have obtained all necessary information and other data required for executing the work.
