In case the assigned store materials are not found in accordance with prescribed specification and approval sample, the UGVCL, shall exercise its discretionary power either to recover from supplier or by way of penalty or to purchase from elsewhere at the risk and cost of supplier. The defective and having bad designs and imperfect other than specified in Schedule 'B' will not be accepted and it will be rejected at the cost and risk of supplier.

## <u>Conditions to Supply for Supply of 11 KV 400 Amps G.O.D. Switch for SDT</u> for feeder bifurcation and Maintenance

- 1. The approved specimens of entire supply of the material, with the paper seal duly discharged by the supplier and the UGVCL authority will be kept at UGVCL Division Office. In case of any discrepancies/ litigation arising out of any issue related to the supply; the specimen kept at this office will be taken in to accounts, only.
- 2. Package information: Each package lot shall be marked with the Manufacture name, Purchase Order, Item description, pack size, packs weight and applicable IS standard. (not with oil immersed)
- 3. In case of any discrepancy, the E-I-C will provide the guide lines and the contractor will have to follow the same. The discretion of the authority issuing the tender and above will be binding to the contractor.
- 4. Material should be supply after approval of sample.
- 5. Bidder shall submit Technical bid & Price bid in separate cover. And this two bid submit in one cover also.
- 6. Bidder must have to submit sample along with the tender. Tender without sample is liable to rejected.
- 7. Material should be supplied at division Store free of cost.
- **8.** The rate of material is excluding all GST & service charge.

#### **GENERAL CONDITIONS:**

- 1. Time limit 30 days from the date of the order issued.
- 2. No. Extra charge or any escalation charge will be paid by company
- 3. Inferior and Poor quality material will be rejected.
- 4. Submission of a bid by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the supply to be executed and local conditions and other factors having bearing on the execution of the supply.
- 5. For new supplier initially 10% will be awarded for performance review. After satisfactory Performance remaining will be extended OR in case of poor performance undersigned reserve right to cancel the rest of order.

#### GENERAL CONDITIONS:-

#### 1. Earnest Money Deposit:-

- A. Earnest Money Deposit 1% of the estimated cost or minimum Rs.500/- or indicated on the Tender Copy should be paid by the tenderer alongwith the tender fee in cash or by demand draft on any schedule bank in favour of UGVCL in which cash receipt shall be attached with tender invariably.
- B. Tender without earnest money will not be considered for acceptance.
- C. Earnest Money Deposit will be forfeited in case the successful tenderer after his tender has been accepted fails to pay the prescribed Security Deposit.

#### 2. Acceptance of Tender:-

The UGVCL does not bind itself to accept the lowest or any tender, without give any reason be assigned for the rejection. It is also not binding on the UGVCL to disclose any analysis reports on the tender. Conditionally tender will not be accepted.

#### 3. Security Deposit:-

The lowest tender whose tender is accepted shall have to pay 10% security deposit of the order value within 10 days from the receipt of the acceptance order. If you fail to supply the material within time limit your security deposit will be forfeited.

## 4. Taxes and Duties:-

The prices are excluding GST and Cess as applicable which will be paid extra on a given taxable goods and/or services within the original contractual delivery period. The amount and % of GST and Cess as applicable should clearly be indicated separately. (GST/Cess means all applicable Tax/Cess under GST Laws. GST Laws means IGST Act, GST (Compensation to the State for Loss of Revenue) Act, CGST Act, UGST Act and SGST Act, 2017and all related ancilliary legislations).

Supplier/Contractor should charge GST in Invoice at the rate as agreed to / mentioned in acceptance of tender only and any deviation in the same shall not be accepted. Further, any additional liability of GST (later on due to wrong mentioning of GST rate, mis-interpretation of HSN/SAC Code, etc.) over and above as charged in the invoice shall be borne by the Supplier/Contractor. However, any refund received by the supplier / contractor on account of GST charged from the company; such refund shall have to be passed on to the company, along with interest if any. Such refund along with interest needs to be passed on suo-moto by the supplier / contractor.

Further, the Company has a right to recover the amount of GST along with penal interest at the rate of 15% per annum if GST charged is not paid / short paid to the government or fail to upload the details or uploads inaccurate particulars on GSTIN portal by the Supplier / Contractor within the stipulated time limit.

In case, Govt. revises the rate of GST rate / Code during the tenure of the contract, the provision of UGVCL's statutory variation clause shall apply.

#### 5. Statutory Variation:-

Any statutory increase or decrease in the taxes and duties including GST and Cess as applicable or in the event of introduction of new tax/cess or cessation of existing tax/cess subsequent to contractors offer if it takes place within the original contractual delivery date will be to COMPANY's account subject to the claim being supported by documentary evidence. However, if any decrease takes place after the contractual delivery date, the advantage will have to be passed on to COMPANY.

#### 6. Jurisdiction:-

Any dispute of difference arising under this connection with contract shall be subject to the exclusive jurisdiction of vISNAGAR (N.G.)

#### 7. Payment:-

- A. The payment will be made within 30 days on receipt of the material by crossed cheque on local bank subject by and advance stamped receipt being received from payee.
- B. Accepting authority reserved the right to rejection of any or all tenders without giving any reason thereof.

#### 8. General:-

- A. The tenderer must quote his rate per units specified the schedule including all taxes in figures as well as in words. It there is difference between rates quoted in words or figures quoted in words shall prevail.
- B. All tender must be submitted in forms provided by this office and must be clearly & legibly filed in. The tenders should be filled in ink. The tenderers are requested to sign wherever mentioned in tender and schedule or rates and if not signed the tender shall be rejected.
- C. GST NO. Copy must be attach with technical bid.

#### 9. Penalty of Late Delivery:-

Penalty shall be @ 0.5% per Week or part thereof plus GST as applicable on delayed portion subject to maximum 10% plus GST as applicable of the delayed portion Order Value (End Cost with GST and Cess as applicable) in case of supply only, whereas in case of Projects, the ceiling shall be with reference to total contract value with GST and Cess as applicable of the project

(Supply + Erection + Civil). For calculating the delayed portion, date of actual receipt of material at store shall be considered.

#### 10. Acceptance of Suppliers:-

In case of any dispute regarding supply of material or any other defect found. The undersigned will have full right to reject the entire quantity and binding to the supplier.
