- 4>> Technical bid is to be submitted in a separate sealed envelope and subscribing the envelope as “Technical Bid”.
- 5>> **The supplier should approve the sample before starting of work.**

Technical bid should be submitted with documents as under, failing which tender is liable for rejection.

- a) PAN Card
- b) Insurance copy
- c) Work Experience certificate for similar Type Earthing with material supply & labor work issued by authorized officer of Distribution Company under GUVNL
- d) Electrical contractor license if applicable
- e) Labor license if applicable
- f) Vender Registration certificate in appropriate class as contractor in UGVCL. Bid of the bidder without vender registration, will not be consider for further evaluations

- 23>> After completion of work, inspection may be carry out by Division/SDn office and any of the supplied items or work found of inferior quality, shall be liable for rejection of the entire work. If require, Earthing resistance will be measure and it should be < 3 ohm.
