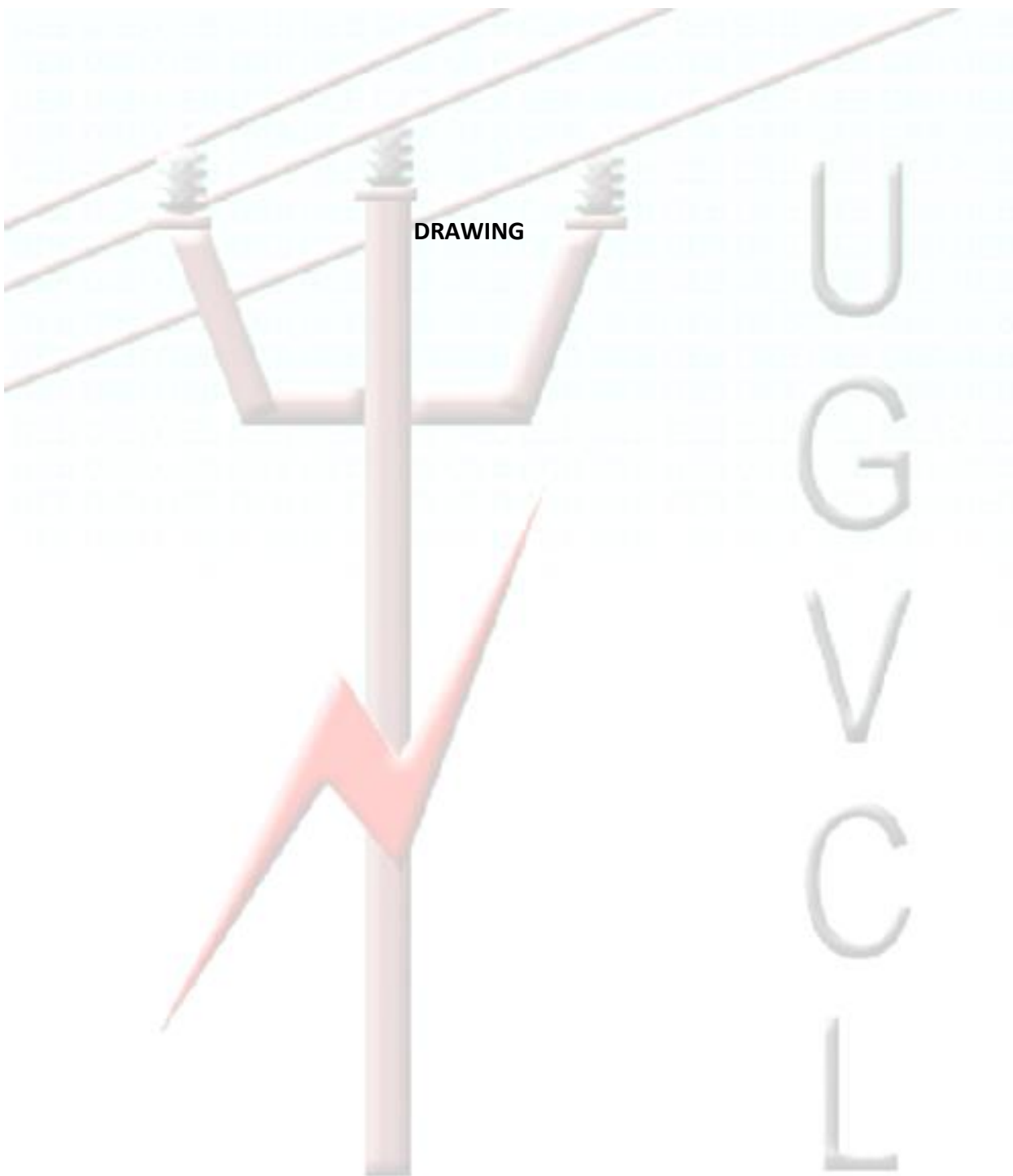

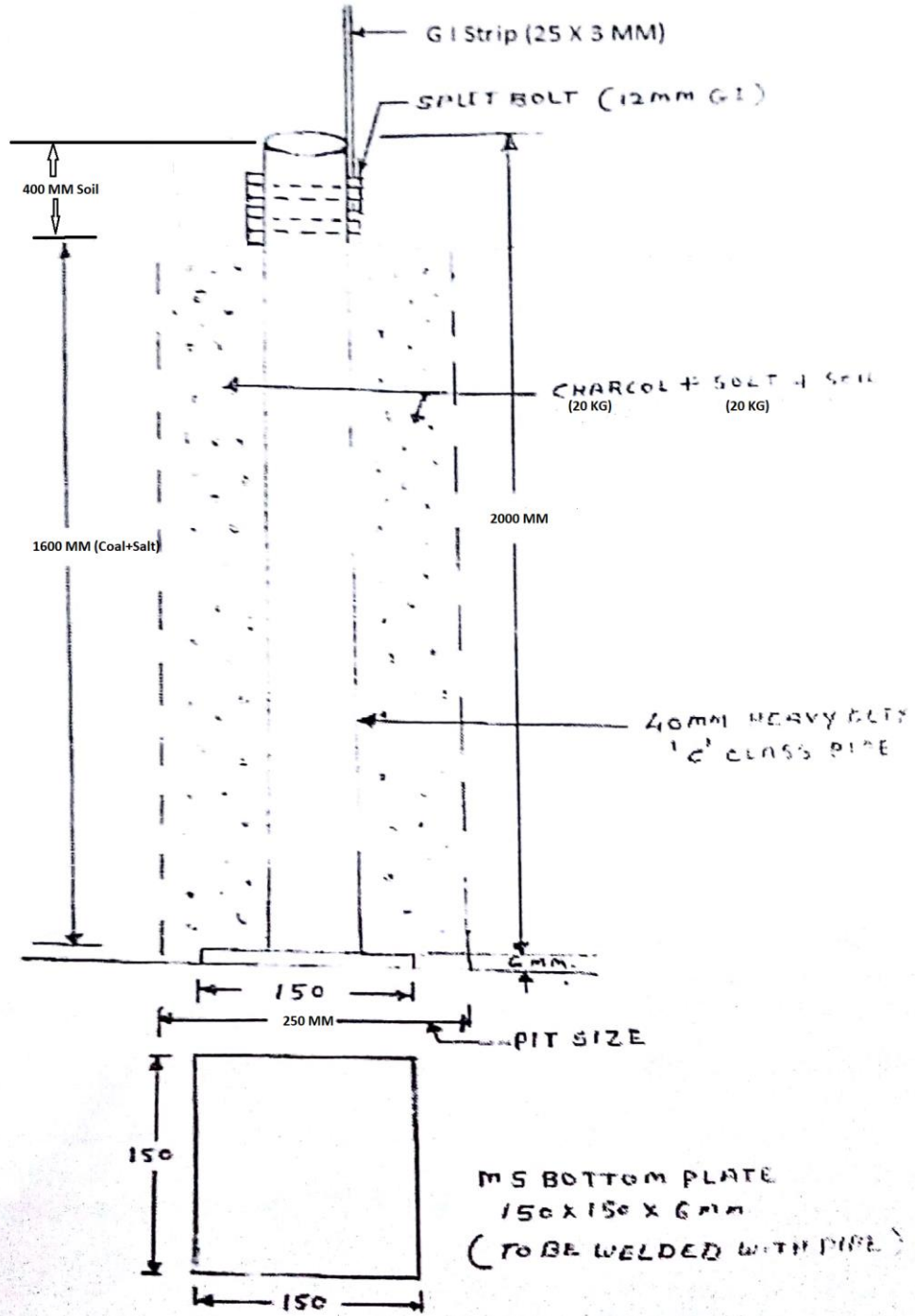

Technical Specification

- (1) GI Pipe 40MM dia Heavy Duty C Class 2 mtr long & 150x150x6 mm MS bottom Plate as per drawing approx weight 6 KG shall be provided by Contractor.
- (2) PVC rigid pipe of 1.25" Dia & 3 MTR Length Generally used to encase the 25X3MM GI strip shall be provided by Contractor.
- (3) Hot Dip Type G I Strip of size 25 mm x 3 mm having length of 06 MTR & 12 mm Hole on both side of strip.approx weight 4 KG shall be provided by Contractor.
- (4) The contractor shall have to provide 20 Kg wood charcoal, 20 Kg salt cubes or 40 kg bentonite earthing powder and sundries materials (like G.I Nut-Bolts, lugs Etc) on his own.
- (5) Earthing of only those transformers which were installed two years back should be carried out on priority.
- (6) Failure of such transformer after installation of earthing must be closely monitored of site in charge engineer/supervisor to provide by SDO.
- (7) Work shall be carried out as per instruction of site in charge engineer/supervisor to provide by SDO.
- (8) The work should be executed in presence of representative of UGVCL of site in charge engineer/supervisor to provide by SDO.
- (9) The company/Representative will not be responsible if accident occurred during the work.

B). PRICES:-

The above prices are inclusive of all taxes, levies, Duties etc.except Goods & Service Tax (GST) will be paid extra as applicable from time to Time on a given taxable goods and/or services. Also please mention **SAC Code** and rate of GST as Applicable.

C). GOODS & SERVICE TAX (GST):-

UGVCL GST Registration No. is: - 24AAACU6551F1Z1

The firm prices are exclusive of Goods & service Tax as applicable. The amount and rate (%) of GST as applicable should clearly be indicated separately. (GST means all applicable Tax/cess under GST laws. GST Laws means IGST Act, GST (Compensation to the State for Loss of Revenue) Act CGST Act, UTGST Act and SGST Act-2017 and all related ancillary legislations).Contractor should charge GST in invoice at the rate as agreed to/mentioned in acceptance of tender only any deviation in the same shall not be accepted. Further, any additional liability of GST (later on due to wrong mentioning of GST rate, mis-interpretation of HSN/SAC Code etc;) over and above as charged in the invoice shall be borne by the contractors. However any refund received by the contractor on account of GST charged from the company; such refund shall have to be passed on to the company, along with interest if any. D). STATUTORY VARIATION:-

Any statutory increase or decrease in GST as applicable or in the event of introduction of new tax/cess or cessation of existing tax/cess subsequent to the offer if it takes place within the original contractual completion date will be to Company's account subject to the claim being supported by documentary evidence. However, if any decrease takes place after the contractual delivery date, the advantage will have to be passed on to COMPANY.

E). PENALTYS FOR DELAYS:-

The delivery, erection and commissioning periods (as applicable) shall be guaranteed under penalty clause mentioned below. Any delay that may take place in erection and commissioning activities beyond contractual out of date shall be subject to penalty at the rate of 0.5% of the contract value (of delayed materials/works) per week or part thereof subject to a maximum of 10% of total contract value, Plus GST as applicable.

E). Penalty Condition

If the bill for the work, after reconciling inventory given to contractor and depositing back the surplus material to respective

RSO/Divisional Stores, is not submitted within one month from the work completion date as per work completion date, then penalty @ Rs. 500 per week or part thereof plus applicable GST subject to maximum of 10% of order value plus applicable GST will be deducted.

Bidders shall have to furnish relevant documents for payment of GST as applicable along with each RA.Bill.

The above supplementary documents should be submitted/upload in form of Notarized/self attested true copies in N Procure site only and no physical documents to be submit.

GENERAL CONDITION:

1. Bidders should complete the tender documents as per above mentioned must be submit online in all respects. Only Online documents files should be considered to open the tender on or before submission date. Otherwise tender should be liable for rejection.
2. Bidders are requested to submit price-bid in on line (e-tendering n code form) only and not to submit the price bid in physical form. This is mandatory. If price bid is submitted in physical form, same will not be opened and only on-line (n code) submitted price bid will be considered for evaluation.
3. The bidders shall submit their offer without any deviations in general terms and conditions of the contract or in Technical specification/items. Tenders of such departing may also be rejected. Incomplete and conditional tenders shall not be considered.
4. Intending bidders should submit their tenders after studying all tender's documents carefully and visiting the site for satisfying themselves of actual site conditions, location and accessibility of site and nature, extent of the work involved etc. Submission of tenders implies that bidders have obtained all necessary.
5. Bidders will not be allowed to give sub-contract of the works awarded to him for any, reasons what so ever without permission of the Engineer-in charge.
6. After opening of "Techno-commercial bid" no revised price bid from any bidders will be accepted.
7. Price quoted shall be firm, till overall completion of the work, under contract and there will not be any price escalation.
8. Date of opening of "Price Bid" will be intimated later on to those Bidders who are qualified in Techno Bid. "Price bid" of only qualifying bidders on the basis of Techno-commercial bid shall only be opened. Price of bidders, who are not qualified technically as per requirement of Techno bid shall not be opened.
9. Offers shall be valid for the period of 120 days from the date of opening of price bid. Tenders shall not withdraw tenders during the validity period, failing which their EMD shall be forfeited during the said period of 120 days.

10 If the Tenderer/Bidder/Contractor would stand lowest while opening of the tender, He will be intimated by the competent authority with separate letter & will have to provide their skilled Labours gang within week time & He would have to report in written through respective SDO. Otherwise Second lowest bidder will be given chance at the rate of lowest1.

11. Penalty clause: in case, the work is not completed within the period stipulated in the sub work order, penalty+GST shall be levied at 0.5% per week on the total sub work order subject to maximum 10 % of respective sub work order value with GST. Also If the surplus material, after reconciling inventory given to contractor is not submitted back to respective RSO/Divisional stores, within one month from the work completion date as per work completion date, then penalty @ Rs.500 per week or part there of plus applicable GST subject to maximum of 10% of order value plus applicable GST will be deducted.

12 If work will not be carried out within time limit of sub work order, work will be carried out by other agency at risk and cost of contractor and the amount will be deducted from respective Bill/SD. SDO is authority to decide the agency for non completion of work.

13. Successful Bidder is bound to work under any S/Dn of Division Office Patan in any scheme if require with the same rate, conditions & without any type of extra charges.

14. The contractor should have to keep permanently skilled Labours gang in respective Sub Division for each annual order. If Concern SDO will report that Erection Work is delayed due to non-availability of skilled labour, penalty will be deducted a per rules.

15. Tenders, who do not fulfill all or any of the conditions of the tender of incomplete in any respect, are liable to rejection.
