Sealed tenders are invited for the work of Removal of failed/burnt/augmentation of transformer and erection of new transformer under villages of various S/dn under Visnagar Division from the contractors/firm who have executed works of similar nature and magnitude successfully and who are vender registered under appropriate class. The copy of following documents may be submitted with the tender, falling which tender is liable for rejection.

- i. Solvency certificate issued from any Nationalized Bank amounting to twice of estimated cost.
- ii. Separate EPF code No. allotted by RPFC with paid challan of last six months.
- iii.
- iv. He must Registrater in appropriate class of vender as per tender value in UGVCL or Central/State Government.
- v. Latest income tax clearance certificate with copy of PAN number.
- vi. Experience certificate for executing of similar nature work satisfactory & magnitude of jobs preferably.
- vii. Group Insurance policy of the insured labour's under W.C. Act.
- viii. Details of equipment available with tenderer.
- ix. Electrical contractor License or wireman certificate or Engineer registration.
- x. Copy of last three annual work order for above work carried out in any Discom.
- xi. GST NUMBER COPY.

Other Terms & Conditions:-

1. No tender shall be accepted/opened in any cases which are received after due date and time of the receipt of the tender.
2. No any tender without payment of EMD, will be accepted.
3. The contractor should have to pay 5% of order value as Security Deposit by cash/demand draft of any nationalized Bank, payable at Visnagar.
4. The rates should be quoted in figures & words as per unit specified in Schedule-B, in case of any discrepancy between the rates quoted in words & figures, then the rate quoted in words will prevails. Any Tender found with overwriting /correction on the rate will not be accepted.
5. Price quoted shall be firm, till overall completion of the work, under contract and there will not be any price escalation.
6. Offers shall be valid for the period of 120 days from the date of opening of tender. The tenders should not be withdrawn during the validity period, failing which their EMD shall be forfeited & future dealing will be stopped with said bidder.
7. UTTAR GUJARAT VIJ COMPANY LTD, reserve the right to reject any or all tender without assigning any reasons.
8. The bill in duplicate quoting GST No. & Pan No. may be submitted to the concern Deputy Engineer, Sub-division office, along with advance stamp receipt & details statement of transformer replaced/erected/installed during the month by mentioning full details of transformer as well as M.R. No.& date and C.R.No. & date.
9. The Income tax as per Govt. rules in force will be deducted from your every regular bill while making payment.
10. The rates should be quoted exclusive of GST. The GST will be reimbursed at prevailing rate on production of paid challan.
11. In case the work will not completed within the period stipulated in the order, penalty shall be levied at ½% per week on the prices (End Cost) subject to maximum 10% of order value of late completion of work **penalty plus applicable taxes if any.**
12. If the bill for the work ,after reconciling inventory given to contractor and disposing back the surplus material, to respective RSO/Divisional stores, is not submitted within one month from the work completion date as per work completion date then penalty @ Rs.500 per week or part thereof plus applicable GST subject to maximum of 10% of order value plus applicable taxes if any.
13. Payment of Bills:: 100% Payment against Bill Recording will be made by concerned Division Office through RTGS/NEFT within 30 days from Account section after verifying the invoices and required documents from concern account section. Payment shall be made by concern Account section of UGVCL, directly to tor and disposing back the surplus material, to respective RSO/Divisional stores, is not submitted within one month from the work completion date as per work completion date then penalty @ Rs.500

per week or part thereof plus applicable GST subject to maximum of 10% of order value plus applicable taxes if any

- 14.UGVCL reserves the right to increase or decrease the quantity against each item/s while placing the order.
- 15.New transformer should be taken from UGVCL, Visnagar Division store & old burnt/failed transformer should also be credited in UGVCL, Visnagar Division store.
- 16.The wiring of transformer should be done through experts' persons having good knowledge of the work and as per instruction of engineer in-charge.
- 17.The burnt/failed transformer should be replaced immediately on instruction received from the engineer in charge of the S/dn, or otherwise the work got done from other persons/agencies at your risk & cost.
- 18.During working period one line staff employee of S/dn will be present only for on/off the line. Other work should be done by your labours. The contractor should have to pick up the office line staff employees from the office of S/dn in your vehicle & drop him in your vehicle at the office of the S/dn after completion of work.
- 19.The contractor will be totally held responsible if any accident occurred to the labours of the contractor.
- 20.The contractor will be held responsible any damages to the transformer or company's property during the work, and the amount of damages will be recovered from the contractor.
- 21.The contractor, if shown their inability to carry out the work at any day, then the said work should be got done from the other contractor at the risk & cost of the contractor, which is binding to the contractor.
- 22.All require instrument like chain-pully block, ropes etc. should be utilized by the contractor of their own.
- 23.The contractor should arrange for carting of transformer for their own cost & risk.
- 24.The contractor should have to submit the certificate of last 3 years experience of the lab our engaged by the contractor for the said work.
- 25.The UGVCL has rights to cancel the order by issuing one month notice.
- 26.The UGVCL has rights to extend two months period after completion of the order if require by UGVCL, without any enhancing of rates & same terms & conditions.
- 27.No any responsibility of UGVCL, regarding any accident or any police/ criminal cases, and contractor should complete the work by any other alternative arrangement.
- 28.The contractor should have to execute the agreement with the UGVCL on Rs.300/- non judicial stamp paper. The cost of non judicial stamp paper should be borne by the contactor.
- 29.The prevailing rules and regulation time to time of the company will be binding to the contractor.
- 30.Per transformer 25% amount will be deducted from the contractor's bill for more than one transformer replaced during per day per trip the same village.
