- 3. Tender documents are in two bids system i.e. "Technical Bid" and "Price Bid".
- 4. Technical bid is to be submitted in a separate sealed envelope and subscribing the envelope as"

 Technical Bid".

Technical bid should be submitted with documents as under, failing which tender is liable for rejection.

- a. Solvency certificate issued from any Nationalized/Scheduled Bank amounting to sum equivalent of estimated cost.
- b. PAN Card
- c. EPF Registration And EPF Paid Challan copy of Last 6 Months.
- d. Labour Insurance copy.
- e. Work Experience certificate for similar CI Pipe Type Earthing with material supply & labour work of minimum amount 10 lacs issued by authorized officer of Distribution Company under GUVNL. Experience certificate should be mentioned with work order number & date and work completion Amount with the attachment of Work order Copy.
- f. Electrical contractor license if applicable
- g. Labour license if applicable
- h. Vendor Registration Certificate in **Class C & Above** as a contractor Under GUVNL Or its subsidiary company
- i. GST Registration Certificate If applicable

j. Each page of the Tender down loaded from the Website is to be signed by the authorized signatory/person & the rubber seal of the Company/Firm shall also have to be provided on each page by bidder.

The above documents should be submitted in form of self attested true copies along with technical bid.

- 5. The sealed price bids comprising of Schedule-'B' should be submitted in separate sealed envelope subscribing the envelope as "Price Bid".
- 6. Both "Technical" and" Price" bid should be submit in different envelope subscribing the name of the work and tender opening date etc.
- 7. Failing submission of any of one bid cause for rejection of tender.
- 8. "Price bid" of only qualifying bidders on the basis of Technical bid shall only be opened. Price of bidders, who are not qualified technically as per requirement of technical bid shall not be opened.
- 9. The bidders shall submit their offer without any deviations in general terms and conditions of the contract or in Technical specification/items. Tenders of such deviations may also be rejected. Incomplete and conditional tenders shall not be considered.
- 10. The rates shall be quoted both in words and figures as per unit specified in schedule-'B' in case of any discrepancy between the rates quoted in words & figures, rate quoted in words will prevail.
- 11. Intending bidders should submit their tenders after studying all tenders documents carefully and visiting the site for satisfying themselves of actual site conditions, location and accessibility of site and nature, extent of the work involved etc. Submission of tenders implies that bidders have obtained all necessary information and other data required for executing the work.

- 17. The supplied materials should have long shelf life, at least of 1 year. In case of any of the item goes degraded, the supplier shall be required to replace the same, at his cost and risk. Security deposit will be refundable after the completion of this guarantee period.
- 18. If you fail to work within time limit your security deposit will be forfeited.
- 19. After completion of work, inspection may be carry out by Division/SDn office and any of the supplied items or work found of inferior quality, shall be liable for rejection of the entire work. If require, Earthing resistance will be measure and it should be < 5 ohm.
- 20. Work may be allotted by EIC as & when it is require. Successful Bidder is bound to work under any S/Dn of Division Office Mehsana if require. Concern authority may transfer your total/partial order to any S/Dn of Division Office Mehsana & Bidders is bound to work there with the same rate, conditions & without any type of extra charges.
