TERM AND CONDITIONS

1. The contractor will have to give the following undertaking.

A. Should this tender be accepted I/we hereby agree to a bide by fulfill all the terms and provision of the tender and contract of works as applicable and in fault there of to forfeit and pay to the company the sum of money due.

B. The full value of earnest money deposit paid herewith should be absolutely forfeited to the Company, should I/we not deposit the full amount of specified Security Deposit, within specified time limit.

C. The contractor shall co-operate with the Company in recording measurement etc. as expeditiously as possible and he shall fulfill all the requirements which are necessary to finalize his outstanding bills within one month from the date of completion of work. Failing which the Company shall finalize the account on the basis of its records and pay him such amount as found due to him together with the amount of Security Deposit, if any, remaining payable to him after deducting there from the amount due by him to the Company for shortage of materials rectification in complete work etc. and the Company shall not entertain any further claim from him thereafter.

D. The competent authority can delete any item in schedule 'B' on the tender if he feels that the rat quoted by the contractor for that item is abnormally high when compared to the estimate rate.

E. In case of any dispute E.E. will be the final authority for deciding the same and his decision will be final and binding on the contractor and Department and no further appeal will be entertained.

F.The contractor will have to see that safety equipments are used by his laborers etc. While working on line, equipment etc. of the Company and he will be responsible for the same.

G.The contractor will have to under taken responsibility of accidents etc. for his persons working on line and same will be on stamped paper of Rs.300 or the appropriate value (if revised by Gove) The cost of stamped will be borne by contractor.

H.The contractors will have to take insurance of suitable amount for his labourers.

I. The contractor will have to give the Bank Guarantee, against solvency which will be 20% of contract value No materials will be issued, if contractor fails to furnish the Bank guarantee of appropriate value.

J.Contractors should be carried out the work under supervision of UGVCL.

General Terms & Conditions

Sealed Tenders are invited for the work of Replacement of Distribution Transformer from the contractors/firms who have executed works of similar nature and magnitude successfully.

- 1. Date of Demand Draft should not be older than 15 Days from the last date of receiving of tender. If D.D is older & its due date is over or bank not accept the same due to any reason at the time of opening of Technical Bid, authority may reject your tender.
- 2. Tender documents are in two bids system i.e. "Technical Bid" and "Price Bid".
- 3. Technical bid is to be submitted in a separate sealed envelope and subscribing the envelope as "Technical Bid".

Technical bid should be submitted with documents as under, failing which tender is liable for rejection.

- a) D.D of Tender Fee & E.M.D.
- b) Solvency certificate shall be submitted as per the clause num 5 of General terms and condition of the tender.
- c) PAN Card
- d) EPF Registration and EPF Paid Challan copy
- e) Insurance copy
- f) Latest income tax Return Copy.
- g) Electrical contractor license if applicable
- h) Labour license if applicable
- i) GST Registration If applicable
- j) Experience :-Contractor should produce evidence of having experience in executing similar nature & magnitude of jobs preferably photo copy of orders secured from UGVCL /Central/ State Government /Railway / Semi Government and satisfactory completion certificate from respective department.& Certificate as per requirement for the WORK OF REPLACEMENT OF FAIL,BURNT,AUGMENTATIO DIST.TRANSFORMER/CTPT and Erection of HT LT TC by authorized officer of Distribution Company. Experience must be as least 1 Year or more.

The above documents should be submitted in form of attested true copies along with technical bid.

- 4. The sealed price bids comprising of Schedule-'B' should be submitted in separate sealed envelope subscribing the envelope as "Price Bid" & also subscribing the name of the work and tender opening date.
- 5. Bidder must submit both Technical Bid & Price Bid separately. Failing any of one bid cause for rejection of tender.
- 6. Envelope without subscribing "Price Bid" or "Technical Bid" will not be accepted & Tender will be rejected.

certificate issued from bank from time to Finance Department, as under. The solvency have to be renewed whenever asked for in period.

- 10. Tenders, which do not fulfill all or any of the conditions of the tender of incomplete in any respect, are liable to rejection.
- 11. The rates shall be quoted both in words and figures as per unit specified in schedule-B. In case of any discrepancy between the rates quoted in words & figures, rate quoted in words will prevail.
- 12. - 15. All the works shall be carried out as per standard specifications & as per instruction of Engineer in Charge.



- 16. The Work Quantity may be increase or decrease during actual work within order amount.
- 17. Contractor has to provide necessary instrument like vehicle with full insurance & its relevant documents renewed from time to time, chain pulley block etc for the replacement of distribution transformer.

- 18. For the replacement of distribution transformer only one line staff will be provide from concern s/dn to take Line Clearance.
- 19. Contractor has to collect MR , CR , Consumer Detail, Transformer Detail etc from concern s/dn office at every morning 09.00 HRS
- 20. Division Store timing is 10.30 HRS to 18.10 HRS. So contractor should collect or credit transformer with necessary documents like MR/CR during this time of office working days only.
- 21. If necessary, contractor has to replace distribution transformer on holidays also. Which detail should be collect from concern s/dn.
- 22. Contactor has to replace Transformer within 24 Hours after getting necessary documents from concern s/dn office. And also Failed Transformer has to be credited within 48 Hours from the date & time of replacement otherwise an amount of Rs. 200/- plus applicable taxes per day shall be deducted as penalty. If no of fail transformers is higher , contractor has to hire more vehicle & labour to replace the fail Transformer within 24 Hours
- 23. In case if the work is not completed within time limit than necessary arrangement will be done by s/dn officer and its cost will be recover from your bill.
- 24. Contractor is responsible for any type of accident during Transformer replacement/ Carting/ Loading/ Unloading Etc. If any damage to UGVCL property, UGVCL may recover from contractor Bill.
- 25. Income Tax at prevailing rate will be deducted as per Income Tax Act.
- 26. An Agreement on stamp paper of Rs 300 should be execute with UGVCL that if any transformer stolen during lifted division store to installation at consumer premises, contractor is responsible for that & amount will be recover from contractor.
- 27. Any dispute of difference arising under this connection with contract shall be subject to the exclusive jurisdiction of UGVCL Mehsana Division.
- 28. In case of any dispute regarding work or any other defect found. The undersigned will Have full right to stop payment in case of unsatisfactory work and that will bind to the Contractor.
- 29. Commercial & Technical Specifications of the work stated in subject are as per UGVCL & Formerly GEB norms and conditions.
- 30. UTTAR GUJARAT VIJ COMPANY LTD, reserves the right to reject any or all tenders without assigning any reason thereof.

35. TERMS OF PAYMENT:

(a) The payment will be made to the contactor by crossed/Account payee cheque on local Bank subject an advance stamped receipt being received from payee.(b) The total payment through all the R.A.Bills combined to gather will not exceed 75% or the order value of the sub-order placed against the annual rate contract.
