3. Tender documents are in two bids system i.e. “Technical Bid” and “Price Bid”.
4. Technical bid is to be submitted in a separate sealed envelope and subscribing the envelope  
As “Technical Bid”, Name of the work and tender opening date etc. Technical bid should be  
submitted with documents as under, failing which tender is liable for rejection.
  - a. Solvency certificate issued from any Nationalized/Scheduled Bank amounting to sum  
equivalent of estimated cost (Minimum 5.0 Lacks)
  - c. Latest income tax Return Copy
  - d. Work order copy for work of Fabrication of material in any Distribution Company subsidiary of  
only GUVNL or Minimum 3 years of various fabrication work experience or UGVCL line  
material material fabrication work experience is to be required by participating firm.
  - e. GST Registration certificate If applicable.

The above documents should be submitted in form of attested true copies along with technical bid.

5. The sealed price bids comprising of Schedule-‘B’ should be submit in separate sealed envelope

## **GENERAL TERMS AND CONDITION FOR WORKS**

### **1.Vender Registration**

The vender registration is not carried out by UGVCL for fabricator. Hence, there is no any requirement of vender registration in any class.

### **2.Work experience certificate.**

**Work experience certificate in GUVNL/GETCO or any other similar type of fabrication work executed by fabricator like welding ,drilling,cutting,threading,bending etc presenting bills copy for fresh contractor with minimum 3 years of various fabrication work experience or UGVCL line material fabrication work experience required by participating firm**

### **3. Document to be submitted by contractor with tender copy**

The vender registration certificate is not required and work experience certificate and supporting documents of bills, order ,pan card,latest income tax return copy ,GST No the solvency certificate and can be produced only for eligible lowest tender firm.

### **4.Time period of material fabrication**

The fabricator has to fabricate the material with in 30 days from steel material received and sub work order given.

### **5.Quantity allocation of new bidder:**

If new fresh vendor has quoted less than the regular ones, it is eligible for quantity distribution of 25% of total quantity .And the 75% of order quantity should be issued to the old firm with matching the price rate of L1. After satisfactory completion of 25% Order allow fabricator vender as regular in next tender process

### **6.Scrap Material percentage**

Scrap should not be more than 1.5 %. No any percentage margin will not be allowed (i.e. Raw material wt.= Ready material wt. + Scrap wt.)

### **7. Earnest Money Deposit**

A. Earnest Money Deposit 1% of the estimated cost or minimum Rs.5000/- or indicated on the Tender Copy should be paid by the tendered along with the tender fee in cash or by demand draft on any schedule bank in favour of UGVCL in which cash receipt shall be attached with tender invariably.

B. Tender without earnest money will not be considered for acceptance.

C. Earnest Money Deposit will be forfeited in case the successful tendered after his tender has been accepted fails to pay the prescribed Security Deposit.

### **8. STATUTORY VARIATION:**

Any statutory increase or decrease in the taxes and duties including GST and Cess as applicable or in the event of introduction of new tax/cess or cessation of existing tax/cess subsequent to contractors offer if it takes place within the original contractual delivery date will be to



COMPANYs account subject to the claim being supported by documentary evidence. However, if any decrease takes place after the contractual delivery date, the advantage will have to be passed on to COMPANY.

## **9. PENALTY FOR LATE DELIVERY**

Penalty shall be @ 0.5% per Week or part thereof plus GST as applicable on delayed portion subject to maximum 10% plus GST as applicable of the delayed portion Order Value (End Cost with GST and Cess as applicable) in case of supply only, whereas in case of Projects, the ceiling shall be with reference to total contract value with GST and Cess as applicable of the project (Supply +Erection + Civil). For calculating the delayed portion, date of actual receipt of material at store shall be considered.

If the bill for the work after reconciling inventory given to contractors and depositing back the surplus material to respective RSO\Divisional Stores, is not submitted within one month from the work completion date, then penalty @ Rs.500 per week or part thereof plus applicable GST subject to maximum of 10% of order value plus applicable GST will be deducted

B. Income Tax at prevailing rate will be deducted as per Income tax Act.

C. All tender must be submitted in forms provided by this office and must be clearly & legibly filled in. The tenders should be filled in ink. The tenderers are requested to sign wherever mentioned in tender and schedule or rates and if not signed the tender shall be rejected.

## **10. Penalty of Late Delivery**

In case if the materials are not supplied within time limit the penalty for late delivery will be charged as decided by the competent authority.

## **11. Acceptance of Supplier**

In case of any dispute regarding supply of material or any other defect found. The undersigned will have full right to reject the entire supplied quantity or to stop payment in case of unsatisfactory work and that will be binding to the supplier.

## **12. Payment**

A. The payment will be made within 30 days on receipt of the material by RTGS / NEFT and advance stamped receipt being received from payee.

B. Accepting authority reserved the right to rejection of any or all tenders without giving any reason thereof.

## **13. Security of Fabricator premises**

The fabricator must take proper security for material lying at their store after getting order fabricator must install CCTV camera facility on their workshop. Also UGVCL officers have to provide excess of the CCTV footage as and when required by company.

**14.** If required the acceptance test is to be carried out at your premises. If you will not provide any Facility for testing, the necessary testing will be carried out at ERDA Lab. Baroda at your risk & cost. UGVCL, D. 50x50x6 mm /65x65x6 Angle / 16mm<sup>2</sup> MS round bar /50x6mm MS flat/100x50x6mm MS channel will be supplied by UGVCL.

**15.** Any dispute of difference arising under this connection with contract shall be subject to the exclusive jurisdiction of UGVCL Visnagar DO. (N.G.).

**16. Other**

Ready material shall be carted by UGVCL at DSO Visnagar (Way bridge charge for weight of ready material paid by agency). Distance of Material carted by UGVCL from your firm will not more than 30 kms from Division office of UGVCL, Visnagar. (Way bridge charge for weight of material paid by agency)

**17.**Scrap should not be more than 1.5%.

**18.**Fabrication should be done as per drawings & specification / sample & instruction.

**19.**In all fabrication item Quantity may be change as per our requirement within total amount of tender.

**20.**This will be an annual rate contract detailed sub work order will placed by time to time as per our requirement and bills will be finalized as per sub work order.

**21.**Fabrication should be done as per drawings & specification / Sample & Instruction of E-I-C. Good quality paints & red oxide like Asian, Nerolac, burger etc. make shall only be applied on fabricated materials Painting.

**22.**If the contractor having any work order or supply order under respective Division office & security deposited not paid till the date of display of this tender then it is considered such contractor is negligent to complete work in stipulated time limit and not achieving work progress as per UGVCL requirement & which may leads probability of accident.
