**INDEMNITY BOND**

KNOW ALL MEN BY THESE PRESENTS that we,.....  
.....(hereinafter called “THE CONTRACTOR” which expression shall, where the context so admits, include their heirs, executors, administrators and legal representatives, successors and permitted assigns) are hereby held and firmly bind unto the Uttar Gujarat Vij Company Limited (herein after called “UGVCL” which expression shall where the context so admits, include its successors and assigns) to take the complete responsibility of the satellite imageries supplied by us regarding the genuineness of its purchase. It is to confirm that the Satellite Imageries are purchased from source confirming the Indian Laws & they are purchased in the name of UGVCL. Satellite Imagery being the Classified data will not be allowed to be misused or to go in the wrong hands which is indemnified by us. We will be providing the Imageries as per above conditions to the UGVCL under the terms and conditions of A/T No..... . We are responsible against any loss, damage or deterioration of whatsoever nature occurs to the said Images supplied to the UGVCL and which are in the custody of the contractor at his works site on behalf of the UGVCL or if any of the said images when inspected by any Officer authorized by the UGVCL in this behalf is found to be damaged, lost, deteriorated in quality, the contractor hereby agrees to replace the Imagery to UGVCL and hereby binds himself to indemnify and at all times keep indemnified UGVCL against all loss, damage, misuse and deterioration to the Images to be supplied to UGVCL within the period of your Order, the market value of such loss, damage and deterioration in full to the UGVCL and shall also authorize the UGVCL to deduct the said sum from any sum due to the contractor or any sum which at any time may become due to the contractor under the above referred contract or any other contract entered into by the contractor with UGVCL.

AND WHEREAS THE contractor do hereby agree to be responsible for the safe custody, protection and preservation of the said imageries against all risks excluding war risks and against loss, damage, misuse and deterioration of whatsoever nature in respect of the said imageries while it remains in the custody and possession of the contractor.

AND WHEREAS the said imageries shall at all times be open for inspection by any Officer authorized by UGVCL.

Now the conditions of the above written Bond are such the contractors shall pay the full amount forthwith to UGVCL in the event of loss, damage or deterioration or whatsoever except due to circumstances arising out of war or natural calamities in respect of the imageries supplied to UGVCL and shall fully and effectually indemnify and keep indemnified the UGVCL against such loss, damage, misuse or deterioration in time or any other liabilities arising henceforth.

The contractor shall keep the said imageries open at all times for inspection by the Officers authorized by UGVCL and produce at anytime when demanded.
