P R E A M B L E :

The State Government has decided to introduce Horse Power based tariff for agricultural consumer w.e.f.1.6.1987. However during the year 1999-2000, based on the recommendations of the ADB, the Agriculture subsidy was capped at Rs. 1100.00 Crores which was then almost equivalent to Electricity Duty and Tax on sale of Electricity so as not to have any net out go from the State Exchequer. Erstwhile, GEB find a tariff petition before the Hon'ble commission in the year 2000. At the time of deciding tariff of agricultural consumers, agriculture subsidy of Rs. 1100.00 cr was considered as revenue receipt from the State Government. As a policy decision, based on the recommendations of ADB, the State Government decided to cap the HP based subsidy at Rs. 1100.00 crores, with effect from the year 1999-2000 for the meter based and HP base agriculture consumers. Therefore, a budget provision of Rs. 1100/- crores (Rupees Eleven Hundred crores only) is made for granting subsidy to Gujarat Urja Vikas Nigam Limited under Revenue in the Budget Estimates for the year 2020-21.

The proposal for release the subsidy to GUVNL for the month of April to May, 2020 was under consideration of the State Government.
