Technical experience and financial resources executed through subcontract shall not be taken into account in determining the Bidder's compliance with the qualifying criteria. The bid can be submitted by an Individual firm only; Joint Venture Firms are not allowed.
3	Qualifying Criteria	РоС	Only three trials of PoC will be given for showing the successful result of the Project. All the three trials shall have to be completed on the same day of PoC.
4	Qualifying Criteria	Turnover	Average Annual Financial Turnover during last three financial years, ending 31 st March 2020 shall be at least 30% of Tender Value supported by certificate duly audited by Chartered Accountant. For the turnover of last financial year (FY 2019-20), bidder may submit the provisional turnover certificate, duly certified by Chartered Accountant.
5	Vendor Registration		Being a pilot project and newly invented item; Vendor Registration is not required.
6	Electrical Contractor License	Instruction to Bidder 31	The work shall have to be executed through valid Electrical Licensed Contractor; the successful bidder shall have to submit copy of such license. If the Electrical Contractor License is not on the name of the bidder and work is to be executed through other Electrical Licensed Contractor, in that case, the bidder has to submit valid Electrical contractor license of that electrical contractor and agreement between the bidder and that electrical contractor. For the same, all responsibilities during warrantee / guarantee period shall be with the successful bidder only.
