### **GENERAL TERMS AND CONDITION OF CONTRACT**

#### 1.0 General Particulars

On behalf of the Gujarat Power Research and Development (GPRD)Cell, GUVNL, Gandhinagar, the UGVCL, Mehsana here in after called 'OWNER' intends to receive bids for the Research Pilot Project for Turnkey Based Supply, Installation, Testing and Commissioning with three year CMC of newly developed concept of Pole Mounted 1.1kV Smart Power Distribution Boxes (SD\_1.1) comprises the various objectives of metering, monitoring & controlling power supply of single phase consumers for the reduction of distribution losses at specific location under UGVCL. The supplied power distribution Boxes shall be installed, commissioned and tested at power distribution network of distribution utilities UGVCL. This is the research based pilot project proposed by GPRD Cell, GUVNL and during the scope of CMC, the bidder shall be required to support for some modifications. The bids shall be prepared and furnished as per these Instructions.

#### 2.0 Scope of the proposal and Work

- 2.1 This is the research based pilot project. The Scope of the proposal shall be on the basis of a single Bidder's responsibility, completely covering all the equipments/Material and installation services specified under the accompanying technical Specifications. It will include among others as specified therein the following:
  - a) Detailed engineering as per GPRD Cell instructions.
  - b) Complete manufacture including shop testing as per GPRD Cell instructions.
  - c) Providing engineering drawings, data, operation manual, etc for the Owner's approval.
  - d) Packing and transportation from the manufacturer's works to the Site anywhere in Gujarat.
  - e) Receipt storage, preservation and conservation of equipment & at the Site.
  - f) Pre-assembly, if any, insurance, erection, laying, testing and commissioning of all the equipments/accessories/material/cable etc.
  - g) The contractual period for execution of work stated in Schedule: B of this project consist of 1 (one) month commencement period and 6 (six) months execution period. The guarantee & CMC period of three year after the date of work completion. The contract period may further be extended up to 5 years as mutually agreed and on the performance of the system during the contract period of one year.
  - h) The successful bidder shall require to remain in contact with GPRD Cell as well as concern DISCOMs for smooth operation, implementation and modifications of research project.
  - i) The successful bidder shall require to submit daily progress report to GPRD cell and respective DISCOM.
- **2.2** Bids not covering the above cited entire scope of works may be treated as incomplete and hence rejected.

- 2.3 The Bidder shall complete all the schedules & annexure in the Bid Proposal Sheets, Technical Data Sheets and specified elsewhere. The Qualifying Data should be filled in the required schedule of Bid Proposal Sheets.
- 2.4 This specification covers the detailing, engineering, manufacturing, testing at works, packing, supply, storage, insurance and handling at site, erection, testing, commissioning and handling over in ready to switch on condition to respective DISCOMS.

## 2.5 Scope of work:

- 2.5.2 The Metallic intelligent power distribution box comprises of single-phase natural air cooled dry type distribution transformer of 3KVA/ 5KVA rating, 1.1/0.240 KV No Load Voltage ratio, a compartment for 03/06 Nos. A. C. Single-phase two-wire, whole current 5-30 Amperes electronics energy meters, High-quality Single pole single throw latching relays for programmable automatic and remote disconnection facility, One nos. of IoT Based DCU consisting of device communication interfaces (inputs/ outputs), microprocessors, data storage, remote communication and auxiliary features as per detailed specification, Power Terminal Blocks, 03/06 Nos. Remote Energy Backlit type Display Unit, 2 core armored control cable for the remote display unit, Plug and Play type terminal block facility for outgoing 2 core power and control cable and required auxiliary components.
- 2.5.3 The Intelligent Power Distribution box to be installed on the LT Pole of Power Distribution Network of the utility. The Intelligent Power Distribution box enclosure shall have two separate compartments each for transformer and consumer metering & controlling be each compartment shall have its separate door fitted with hinges and clamps as per drawing attached with tender. However, there shall be only locking arrangement of the compartment.
  - a. **Transformer Compartment:** A compartment for the installation of one single-phase, 1.1/ 0.24 KV, either 3 OR 5 KVA utility requirements, Natural Air cooled (AN),

CRGO Type Distribution transformer with Louvers and other air natural cooling facility as per enclosed drawing.

- b. **Metering Compartment:** One compartment for the housing of 03 OR 06 Nos, 1 Phase, 2 Wire electronics energy meters for consumer metering, DCU, single pole single throw latching relays, Power terminal blocks and other required accessories associated in low voltage power distribution circuit.
- 2.5.4 The scope also covers to install and commission the display unit in the consumer premises for each consumer supplied through this power distribution arrangement. As per the GERC regulation, it is mandatory to facilitate each consumer to avail for its energy meter electrical parameters recorded in the electricity meter. The installation, interconnection and testing of remote display in the SMC box enclosure at consumer premises shall be in the scope of the bidder.
- 2.5.5 Supply of all such accessories/parts which are useful and necessary for its electrical, electronic and mechanical safe operation deemed to be within the scope of this technical specifications, whether specifically mentioned or not.
- 2.5.6 The supply of single-phase consumer tariff energy meters shall be in the scope of the purchaser. There shall be the requirement of RS 485 MODBUS communication between all the meters and their display units with IoT base DCU.
- 2.5.7 The successful bidder shall supply and install necessary hardware, software & networking for the Data Acquisition System (DAS) at the GPRD cell Central Data Center/DISCOM Central server. The web-based software solution shall be built on service-oriented architecture for data exchange between various other existing and future IT systems of the DISCOM/GPRD Cell.
- 2.5.8 The data shall be stored and made available for various analysis, generation of exception reports, and export to third party systems and energy audit. DCU provided by bidder for Distribution Box should have internal data storage provision. This will be useful in the event of communication failure with the cloud/Central server.
- 2.5.9 The System shall be accessible on the intranet, internet, and the information dissemination would be primarily through a web site designed on responsive technologies for facilitating access through a mobile device, tablets, laptops, desktops, etc.
- 2.5.10 For the data communication; there are various methods for the same and If the successful bidder adopts the GPRS based communication method from DCU to Cloud/data server then provision for dual SIM cards of different service providers shall be in the scope of the bidder The dual SIM cards are required for the redundancy in

data availability. The selected SIM cards shall be 2G, 3G,4G compatible with fallback to 2G and 3Gfor redundancy. The monthly SIM charges will be borne by the bidder. It is the bidder's responsibility to check the network coverage at the site. Please note that bidder is free to use any other communication technology (such as VSAT etc.) other than SIM card to achieve SLA. However, all charges required for communication are to be borne by the bidder. Contractor shall suggest one or more appropriate options for the proven communication technologies working effectively in India. The complete set of equipment shall be offered; for their effective and trouble-free operation. Such parts will be deemed to be within the scope of the supply; irrespective of whether they are specifically indicated in the commercial order or not.

- 2.5.11 The register mapping for instantaneous parameters, Load Survey, Billing data, and Tamper events shall be uniform for all the meter manufacturers. The register address mapping against the parameters shall be as per the enclosed Annexure No: C. Bidder must provide all the parameters irrespective of the make of the meter only in the standard format to confirm the seamless interoperability in the future for the whole system. Interoperability here shall mean, Meter of various make shall be capable to communicate with the IoT based DCU & vice versa.
- 2.5.12 The software should be based on a robust architecture model, a framework that is suitable as per the project including routine operations and maintenance of distribution Company considering 7% annual growth. Initially, the software to be supplied should be suitable for handling up to 1000 Intelligent Power Distribution Boxes and it should be scalable for more as per requirement.
- 2.5.13 The system should be capable of acquiring Instantaneous load parameters on real-time, relay status and programmable intervals as decided by DISCOMs and can pull and push the data as and when required from the controller by GPRS connectivity. Or any other parameter/Details ask by the GPRD/DISCOMs than It shall be provided by the bidders.
- 2.5.14 If any modification felt necessary to improve performance, efficiency, and utility of equipment, the same must be mentioned in the 'Modification schedule' with reasons duly supported by documentary evidence and advantages. Such modifications suggested may or may not be accepted, but the same must be submitted along with Pre-Bid Queries. The modifications not mentioned in Schedule will not be considered.
- 2.5.15 It is not the intent to specify completely here in all the details of the design & construction of material. However, the material shall conform in all respects to high standards of Engineering, design and workmanship operation in a manner acceptable to the purchaser, who will interpret the meanings of drawings and specification and

- **70.5** The Contractor shall prepare detailed packing list of all packages and containers, bundles and loose materials forming each and every consignment dispatched to Site.
- **70.6** The Contractor shall further be responsible for making all necessary arrangements for loading, unloading and other handling right from his works up to the Site and also till the equipment is erected, tested and commissioned. He shall be solely responsible for proper storage and safe custody of all equipment.

#### 71.0 COOPERATION WITH OTHER CONTRACTORS AND CONSULTING ENGINEERS

#### 13.0 FACILITIES TO BE PROVIDED BY THE OWNER

#### 15.0 LINES AND GRADES

All the works shall be performed to the lines, grades and elevations indicated on the drawings. The Contractor shall be responsible to locate and lay-out the works. Basic horizontal and vertical control points will be established and marked by the Engineer at site at suitable points. These points shall be used as datum for the works under the Contract. - 19.2 Contractor shall be responsible for examining all the shipment and notify the Engineer immediately of any damages, storage, discrepancy etc, for the purpose of Engineer's information only. The Contractor shall submit to the Engineer every week a report detailing all the receipts during the week. - IV. The Contractor shall provide suitable safety equipment of prescribed standard to all employees and workmen according to the need.
